April 2024 Step, Tradition, and Concept Four

Step Four

"Made a searching and fearless inventory of ourselves."

I was approaching 5 years sober and I was getting ready to go back out. In my mind I was twirling an ice cube in an old fashion glass looking for a reason to add Scotch. I was still beset with unresolved anger, aka resentments. Anger towards those that had "done me wrong". Fear was directing my life. Fear of not getting what I wanted. Even fear of success. Success, a term not in my personal vocabulary at that time. I was burdened by the weight of my "shuilt". The powerful combination of shame and guilt. Shame and guilt for causing the destruction of my marriage. Deep shame and guilt for choosing alcohol over fatherhood. Shame and guilt at being judged defective, a looser. My emotional sobriety was non-existent.

I had attempted a fearful, shallow 4th Step. Locked myself away with no one to help and tried to write about things that were deeply painful. Events and actions in my life that I was denying, justifying, running from and yes, drinking over. I met with my sponsor [I at least had a sponsor] to give him my 5th Step. When I was finished, he looked at me and said" are you kidding me?" To say the least he was less than impressed with my efforts. Then, one of the recovery angels that exist in the rooms told me about a guided 4th Step workshop.


A Joe and Charlie style workshop facilitated by members who understood what was needed to be searching, fearless and thorough in this quest for my truth. It was a game changer. That point where I truly began to turn sobriety into recovery. I listed who or what I was angry at and why. I wrote about my fears. I took that necessary hard look at the harms I had done with special attention to harms done in my relationships, my sex conduct. Then things took an unexpected turn. I was directed to identify my part in all this. My part, give me a break. I was the victim here, right? Wrong! It became painfully apparent that I had a part in starting and/or continuing many of these inventoried items. The truth shall set me free- with a footnote that at first it will sting!



The lasting value of this 4th Step experience is that it has provided me with information I would need in going forward. Insight into the character defects I would be working on in Steps 6 and 7. A list of my harms was right there in plain sight, allowing me to begin the amends process of Steps 8 and 9. It gave me a format to use for the continuing inventory called for in Step 10.

Step 4 became the foundation, the bedrock upon which I could and have built a sober life.

Notes from Your Board Chair:

April is upon us, and I have a touch of spring fever. Nothing beats the excitement and energy of spring time in Minnesota. It is infectious. April is also the fourth month which means the MIRUS discusses Step, Tradition, and Concept Four. Tradition Four is one of my favorites! The short form of this tradition reads, "Each group should be autonomous except in matters affecting other groups or A.A. as a whole." The founders of Alcoholics Anonymous knew that most alcoholics do not get really excited about rules and regulations and tend to do the opposite of whatever an authority figures tell us to do. I can say this is very true for me. The founders knew that alcoholics needed to learn through their own experience but would eventually adhere to the principles that would ensure the group's survival. According to the Twelve Steps and Twelve Traditions, "We had discovered there was perfect safety in the process of trial and error. So confident of this had we become that the original statement of A.A. tradition [long form of Tradition Four] carried this significant sentence: 'Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group provided that as a group they have no other affiliation." Essentially, every group had the right to be wrong.

A former sponsor of mine studied the traditions extensively and I learned a great deal from her about how to apply the A.A. Traditions to my personal life. Whenever I would call her about something I was struggling with she would ask me, "What

tradition can help you with this?" I almost always guessed Tradition Four and I was usually correct. If Tradition Four meant that every A.A. group has the right to be wrong then it means that every individual has the right to be wrong as well – both inside and outside the rooms of A.A. Understanding this helped me immensely in both my personal and professional life. Sometimes people are going to let me down and that is because people are human and make mistakes. The good news is that this applies to me as well. I am human and make mistakes too. Another important part of Tradition Four is that qualifying statement, "except in matters affecting other groups or A.A. as a whole." When applying this to my personal life it means that I get to make my own decisions unless those decisions affect a relationship or team I am part of. Then I need to consult the other people impacted by that decision. Wait, I should consider other people besides myself? What a concept! It is amazing how much better my relationships with those around me are when I consider how my actions may affect them before actually taking any action. Applying the principles of Tradition Four to my personal life certainly has certainly made my Step Four resentment lists a lot shorter.



Twelve Concepts for World Service, written by Bill W. in 1962

Concept IV

Throughout our Conference structure, we ought to maintain at all responsible levels a traditional "Right of Participation," taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each must discharge. Concept IV provides for participation for all members of A.A. through "voting representation" in all A.A. affairs. What on earth does this mean, and how on earth does it work? In our early days all of the decision making power was granted to, and held, by the Board of Trustees. They governed over all A.A. affairs directing staff members to carry out their wishes. Therefore, the responsibility fell to staff members, separating the decision makers from those carrying out the decisions. As in all of A.A., experience soon showed this was neither practical nor sustainable. This "top down" method of management may work very well in the corporate world, but A.A. is anything but corporate. Guided by spiritual principles we found our way to Concept IV through much trial and error. It was found that all involved in the work should have a say in the decisions, deepening the commitment to the continuation of A.A. The current Conference Charter says this:

- 2. Composition: The Conference (U.S. and Canada) shall be composed of area delegates, the trustees of the General Service Board, directors of A.A. World Services and AA Grapevine, and staff members of the Grapevine and General Service Office. Each participant in the Conference has an equal voice and an equal vote, granted through the "Right of Participation". This ensures that all participants have skin in the game, if you will. Everyone has a stake in the process, not just in implementing the outcomes. This applies to staff members and trustees alike, in equal measure. No one holds ultimate authority over another, Tradition Two makes that abundantly clear:
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

Individual members of A.A. also have the responsibility to participate. While we don't all go to the General Service Conference, we do all participate in learning about the Conference Agenda items and preparing our delegate to attend, through sharing our group conscience with them. One upcoming participation opportunity is March 23, 2024, when Area 36 will hold its Delegate's workshop in Rosemount, MN. Come Participate! Concept IV says this:

There is another good reason for "participation," and this one has to do with our spiritual needs. All of us deeply desire to belong. We want an A.A. relation of brotherly partnership. It is our shining ideal that the "spiritual corporation" of A.A. should never include any members who are regarded as "second class." Deep down, I think this is what we have been struggling to achieve in our world service structure. Here is

perhaps the principal reason why we should continue to ensure "participation" at every important level. Just as there are no second-class A.A.'s, neither should there be any secondclass world service workers, either. The "Right of Participation" is therefore a corrective of ultimate authority because it mitigates its harshness or misuse. It also encourages us who serve A.A. to accept the necessary disciplines that our several tasks require. We can do this when we are sure that we belong, when the fact of our "participation" assures us that we are truly the "trusted servants" described in A.A.'s Tradition Two. I can think of no better reason for participation than nurturing the spiritual needs of myself, and my fellows, thus ensuring the continuation of A.A. for those who will need us in the future. It is a privilege to serve Area 36 and A.A. as a whole, and I look forward to hearing your input and conscience on the agenda items. See you all in Rosemount!

- 2. Does my group consider the welfare of nearby groups in its actions and decisions? Of AA as a whole?
- 3. Do I judge or criticize other members' behavior when it is different from mine, or do I learn from it?
- 4. Do I always bear in mind that, to those outsiders who know I am in AA, I may to some extent represent our entire beloved Fellowship?
- 5. Am I willing to help a newcomer go to any lengths—his lengths, not mine—to stay sober?
- 6. Do I ever criticize certain groups because I think they don't do things how I believe AA should be done?




