# Step Seven

#### "Humbly asked him to remove our shortcomings."

When I was new in sobriety, my arrogance and delusion told me that I could think my way through this program, and this was definitely a step that was easily checked off as "completed" as I was reading the steps off the wall in *your* meetings. When I eventually saw the one paragraph in the big book for this step, that was further confirmation that this was a quick and easy step! It took me a while to admit that I did not have the answers and that I could not be successful in sobriety and life alone, despite having thoroughly thought through the 1st step. I have come across some experience, strength and hope while taking action in practicing *our* program since then. I will do my best to share some of that in a helpful way here in relation to step seven.

The first time I looked at this step with a sponsor I desperately needed to hear that there was hope for me to live a joyful, fulfilling, purposeful life despite everything that had been revealed to me in my 4th and 5th step. I was very exhausted of my patterns, and really of facing facts about myself, after finally working steps four, five, and six. There is an astonishing amount of hope in moving "out from ourselves toward others and toward God" after those steps are worked to the best of my ability. Today I rely on my higher power and strive for humility to bring me to a level of serenity and joy that happens when I am in harmony with my higher power.

When I tried to take action on this step, beyond saying some words, I found myself very confused and then very grateful to have my sponsor right beside me. I was following direction, contemplating, and then discussing what principled actions may look like in situations where my defects arose. This quickly was twisted into a list of demands for God that I expected to be fulfilled. I was telling from a pedestal instead of asking as a one flawed and limited human among many. I found myself single handedly battling my objectionable habitual actions, and had completely excluded any sort of Spirit of the Universe. I had defaulted into the old way of thinking that I needed to manage myself and my life. I was very quickly in emotional pain, experiencing guilt and had not felt so insecure in a long time. This was a situation where my sponsor kindly and lovingly redirected me. She suggested that I may want to

reinvite someone more qualified into the equation. I found that there is a much greater effectiveness for me in the seventh step when I seek opportunities to practice a spiritual way of life, am open to what that will look like, and have faith that intuition and sponsorship serve me well when I am connected to a higher power. My connectivity gains strength when I take purposeful action to build a conscious companionship with my higher power. I aim for dependance and reliance on a power greater than myself. An imperfect practice with prayer, meditation, and self examination has reaped rewards in this regard. I try to communicate with my higher power from a place of answers that are to be revealed and from the perspective that my thoughts are very often wrong. The seventh step places great emphasis on humility as essential. Looking at step seven in the 12 x 12, the word humility is listed a resounding 28 times (allow me room for human error in this number as I only counted once) so I would be remiss not to include this ingredient for growth. My most recent discovery and perspective shift on humility is one that I am enjoying integrating into practice in my daily life. I found it in a writing from the Language of the Heart. It reads, "This is why I see humility for today as that safe and secure stance midway between these violent emotional extremes. It is a quiet place where I can keep enough perspective, and enough balance, to take my next small step up the clearly marked road that points toward eternal values."

I have some fantastic situations for character building, and some strong emotions going on in my life today. I thank AA for the quiet moment with relief from guilt and pride, and the small step up the road that the opportunity to write this has granted me today. I am grateful I can walk beside my fellows and that I continue to build a relationship with The Most Qualified.



# Twelve Concepts for World Service, written by Bill W. in 1962

**CONCEPT VII** 

The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.

This Concept reminds us of the biggest difference between other corporate structures and Alcoholics Anonymous. Other corporate structures are focused on the bottom line, and returns for investors, based in dollars and cents. A.A., on the other hand, is focused on the alcoholic, with returns based in spiritual principles and sense. After a time, it makes sense to me, an individual alcoholic, to adhere to spiritual principles, and it makes sense, as well, for our trustees to do the same. Although they have full legal power to make decisions for our three corporate boards, they do so not for personal gain or glory, but for the good of A.A. as a whole, and for the still suffering alcoholic. There is likely no other board which serves not only the body it answers to, in our case the Fellowship, but also the ultimate authority — a loving God as He may express Himself in our group conscience. Given that, our trustees are called upon to practice the spiritual principles available to all of us, in all their affairs. Concept VII works for our Fellowship on several levels. By allowing the trustees the legal latitude to manage our funds and services, we ensure that the services that are important to us, those we have requested through the General Service Conference process, are available to us. It would be impossible for the Fellowship to undertake that work, so we ask our trustees to manage it, through our corporate boards.

The Concept VII article in the Service Manual tells us this:
This concept may appear to be contradictory; it may look like
the collision of an irresistible force with an immovable object.
On the one hand we see a Board of Trustees which is invested
with complete legal power over A.A.'s funds and services, while
on the other hand we find that A.A.'s General Service
Conference is clothed with such great traditional influence and
financial power that, if necessary, it could overcome the legal
rights of the Board of Trustees. It can therefore give the
Trustees directives and secure compliance with them—
practically speaking Remember, out trustees serve us for fun
and for free, there is no salary attached to these very big jobs.
They study the Traditions and use them and guard them as we
do.

This concept invites all of us, wherever and however we participate in A.A., to embrace our spiritual principles, while assuring us that our trustees, and our corporate boards, are using the same principles to conduct our business. This gives full voice to Tradition Two:

For our group purpose there is but one ultimate authority — a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

## The Twelve Traditions -How They Apply In Our Lives

These questions \* were originally published in Grapevine in conjunction with a series of articles on the Twelve Traditions that ran from November 1969 to September 1971. While they were originally intended as suggestions for individual use, many AA groups have since adopted them and use them as a basis for wider discussion.

Tradition Seven: Every A.A. group ought to be fully self-supporting, declining outside contributions.

- Honestly now, do I do all I can to help AA (my group, my central office, my GSO) remain self-supporting? Could I put a little more into the basket on behalf of the new person who can't afford it yet? How generous was I when drunk in a barroom?
- 2. How do I (or my group) support our International Journals of Alcoholics Anonymous, Grapevine and La Viña?
- 3. If GSO runs short of funds some year, wouldn't it be OK to let the government subsidize AA groups in hospitals and prisons?
- 4. Is it more important for a group to get a big AA collection from a few people, or a smaller collection in which more members participate?
- 5. Is a group treasurer's report unimportant AA business? How does the treasurer feel about it?
- 6. Does my group have a "prudent reserve"? If yes, do I know what that amount is?
- 7. If a family member, work colleague or close friend who is not an AA member wants to make a financial contribution to my group, should the group accept it? What if my group is short on funds?

- You will be expected to; attend all Board and Rep meetings, attend a monthly General Service District meeting, serve on a Board sub committee, participate in functions that are sponsored by Greater Minneapolis Intergroup.
- Your Home Group should be located within the confines of the Metro Minneapolis Suburban Area.
- The Intergroup by-laws require each candidate to have 5 years of continuous sobriety on the date the election is held.
- A business background can be helpful. However, experience at your Home Group, Intergroup, or General Service brings value to the mission of Greater Minneapolis Intergroup.
- No more than (2) two members from the same Home Group can serve on the board at the same time.
- As an elected board member you are serving all the groups in the greater Minneapolis AA community not just your AA Home Group.
- The AA 3<sup>rd</sup> Legacy procedure is the voting process used for our annual election.
- There are (4) four (3) three year term openings. Term begins October 1, 2024 and ends September 30, 2027.
- Minneapolis Intergroup is a non-profit Minnesota Corporation 501(c) (3) and is subject to all State and Federal laws.
- The IG by-laws require that copies of all submitted resumes be sent to the Intergroup Representatives of record by U.S. Mail 7 business days prior to the annual election.
- The Board elections are held annually at the Intergroup Representatives meeting, the 4<sup>th</sup> Thursday in September.







