November 2023 Step, Tradition, and Concept Eleven

"Sought through prayer and meditation to improve our conscious contact with God as we understood him, praying only for knowledge of his will for us and the power to carry that out."

It is with an enthusiasm of joy that I have this opportunity to share my experience of working Step 11, with all of my fellows.

In early recovery it was suggested to me to take the Steps in order, and I believe that is how the program works. Somewhere between Steps 2 and 3, an old-timer pulled me aside and mentioned that I could practice Step 11 at any time. That was good news for me because of my agnostic attitude at that time. The steps do work in my life if I work at them.

As I approached Step 11 for the first time I could easily pray, morning and night, but I have always thought that meditation was for a dedicated clergyman, and I thought that I was not one of them.

I continued my attendance and weekly service work for ten years with this perception. Then a weekend convention in Duluth with Don C. and Don M, who together put on an 11th Step Workshop after they had both shared their experience. Both started with the "Upon Awakening" prayer on page 86 of our Big Book. They mentioned that upon awakening is as soon as I realized I was awake with my head on the pillow, and before my mind started to race. Before any of the possible distractions of the coming day could take my attention away from the fact that I have the gift of life today, and I can be grateful for all of the wonderful things, the blessings that I have received. I know that I would not have any of this if I were still in active Alcoholism. They went on to talk about building traditional disciplines in our prayer and meditation practice. After listening to them, I was willing to start my new journey into meditation. I started with a small increment of time. Even just one minute. Ask my Higher Power to direct my thinking, especially that it was divorced from self-pity, dishonest and self-seeking motives.

The part that seemed most difficult was trying to clear my mind so my Higher Power could come in.



The 11th Step is written specifically "Sought through prayer and meditation" and my willingness to take this Step thoroughly was very strong. The example of my friends who had what I wanted gave me the inspiration to be patient with my results after my early attempts with Step 11 meditation.

My recovery discipline today is "upon awakening" say the page 86 prayer as soon as I am awake, then I make coffee and go to the place in my home where I can be undisturbed. I set my phone for 12 minutes and 12 seconds. In that time, I thank my Higher Power for the gift of life, and for all of the blessings I have. I say the 3rd Step prayer and keep my mind focused on letting my Higher Power in. Most days the chime on my phone goes off while I am in a very good place. I was frustrated in the beginning of this practice because I was expecting an outcome. When I could practice some patience and be diligent in my practice, I was able to realize that my Higher Power was molding me to be the best Joe I could be.

Then I knew that I was practicing Step 11. I was improving my conscious contact with the God of my understanding and being excited for the opportunity to be of service to my fellows.



Twelve Concepts for World Service, written by Bill W. in 1962

CONCEPT XI

While the Trustees hold final responsibility for A.A.'s world service administration, they should always have the assistance of the best possible standing committees, corporate service directors, executives, staffs and consultants. Therefore, the composition of these underlying committees and service boards, the personal qualifications of their members, the manner of their induction into service, the systems of their rotation, the way in which they are related to each other, the special rights and duties of our executives, staffs and consultants, together with a proper basis for the financial compensation of these special workers, will always be matters for serious care and concern.

Concept XI sets out very clear directions for continued effectiveness in carrying the message, from our General Service Board to our Trustees Conference Committees, to our GSO support staff, to our two corporations: A.A.W.S. and A.A. Grapevine.

A case can also be made that this Concept also extends right up our upside-down triangle to our Regions, Areas, Districts and Homegroups. This is another Concept that endeavors to have the most qualified people working on behalf of our Fellowship, and also to empower them with the authority and financial resources necessary to carry out their tasks.

Without that authority and those resources, they would always be empty suits, if you will, dependent all the time on Conference Advisory Actions for direction, which is not practical, given than the General Service Conference meets only once a year.

Our services to the Fellowship, and thus to the still suffering alcoholic must be living breathing and active. Concept XI is a fine mechanism, guided by Bill's vision, to make sure our service is relevant,

prudent, and carried out in the best way possible. I highly recommend all Trusted Servants, wherever in the service structure you currently land, read this concept through thoroughly, it is very wordy, but broken down quite brilliantly, giving us a roadmap for continued service in A.A. and an understanding of our structure at the bottom of the triangle that makes it all possible.

It is an honor to serve Area 36 as your Panel 73 Delegate, and to take our place in the process for these two years.



The Twelve Traditions - How They Apply In Our Lives

TRADITION 11 –Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and films..

Bill W. clearly emphasized on many occasions--and even on tape --that AA members were not to hide behind their anonymity, but rather to respect the anonymity of others.

I happen to have special feelings about anonymity, because I have never had any in the Fellowship.

I happen to be what might be called a two-bit celebrity. I am widely known as a radio and television broadcaster. But my alcoholism stymied my career in those fields so that, though I am easily recognized, I am not necessarily well-regarded.

So be it. This is a consequence of my alcoholism, and I accept it.

Ever since I entered the Fellowship four years ago, I have realized that the fact of my recognizability makes my membership slightly different.

When I go on a commitment, I am recognized on sight, and people are able to identify me by the sound of my voice.

Their reaction is usually the same: they are surprised, and they are pleased. It is comforting, I guess, to find someone who has been detached and identified as "different" to be the same when it comes to alcoholism.

At first it was difficult for me to adapt to a nonentity status in my AA community. But, beginning is difficult for everyone, so I don't claim any particular affliction.

I was made to realize early on that there was a special role for me because of my recognition factor: I would serve as a power of example, as long as I stayed sober; I could do severe damage to AA if I got drunk. Cy W., who had twenty-one years of sobriety when I met him, told me graphically how important it was that I not disappoint people by failing to do everything that was suggested. "If you have a slip, it won't be just a slip, it'll be a mess!" he said.

At first I thought this was an unfair pressure to put on me. It was tough enough to get sober without having to do so as though everyone in the place were watching me. But this turned out to be a distinct advantage, for I had a special and helpful pressure to keep me sober.



Ironically, Cy W. was a fellow who always gave his full name from the podium, or anywhere else, because he had a deep understanding of the true purpose of anonymity within this Fellowship: Anonymity is not to protect our identity; it is to preserve our humility.

So long as my "famous" last name is not used for leverage in my casual social exchanges with my fellows, I am the same as any other Paul--or Emily or Charlie or Tom--in the Fellowship. I will carry that in my attitude, and so will all the people I meet.

But when it comes to a more formal event such as an accident, an illness, a Twelfth Step call, or a reason to send off a letter, I can be designated in full among those I trust and who trust me.

That, in my opinion, is how anonymity should function.

I shall have no fear of any other alcoholic knowing who I am. I shall trust that no one in this Fellowship will tell outsiders that he heard me give my name and designate myself as an alcoholic. And I shall remember that this same blend of anonymity and trust applies to all my activities within AA. I am no different. Therefore, I am no better, no worse.

I have-to remind myself that one of the ingredients of my active alcoholism was a constant drive to make sure everybody, wherever I was, knew that I was there, and knew who I was.

It is entirely fitting, therefore, that a guy like me should wind up anonymous.






