Step Eleven

"Sought through prayer and meditation to improve our conscience contact with God as we understood Him, praying only for knowledge of His will for us and the power to carry that out."

Let's start with why. At this point in the program, having completed the first nine steps, I found myself released from the mental obsession of my alcoholism. To be able to keep this gift, continuous action on my part was required. This began in Step Ten with a moment to moment spot check throughout the day to make sure I stay on the beam.

Here is the how of it from one person's experience.

The way the 11th Step was passed on to me is this: it is set up to bookend those moments in our day by taking action at night before bed and in the morning upon awakening. In the evening it is a quick review of the day to see if I need to correct anything and a short "Thanks for keeping me sober Dude." Other people may say God, Buddha, Allah, Jesus, or whatever they find works best for them. For me it depends on the mood I am in. Hence the God as we understand him at the end of the step.

It is in the morning that I work in concert with the Higher Power to set the tone for the day. I do this by intentionally setting aside time to pray to have my selfish, self centered fears and ways to be released from me. I say intentionally, because this stuff doesn't come naturally. I need to, and get to gently discipline myself into doing the work. This usually incorporates some stock prayers I learned in AA: 3rd Step and 7th Step prayer, the Lord's Prayer and the Serenity Prayer. What this brings to the table is the beginnings of a release from fear, and ideals to strive for as I enter into the world. For what it's worth, I infrequently kneel when saying them, but when I do, it seems to hit deeper.

As these prayers help to settle my thoughts, I begin to go into the next phase, that mysterious thing called meditation. I love that the literature encourages us to explore books, teachings and what ever else we can get our hands on, to better understand not only meditation but prayers as well. Over the years I have read different books, taken classes, and learned from different religious and non-religious teachings to get an idea of what works.

Sometimes, even after the prayers, my thoughts are still running like a squirrel on Red Bull through my mind. This is where meditation does wonders to connect me with my Higher Self. As I think about what needs to get done throughout the day, I also visualize how I want to be in the doing. This for me is really where the rubber hits the road on Step Eleven. Twelve Concepts for World Service, written by Bill W. in 1962

Concept XI:

Long Form: "While the Trustees hold final responsibility for A.A.'s world service administration, they should always have the assistance of the best possible standing committees, corporate service directors, executives, staffs, and consultants. Therefore the composition of these underlying committees and service boards, the personal qualifications of their members, the manner of their induction into service, the systems of their rotation, the way in which they are related to each other, the special rights and duties of our executives, staffs and consultants, together with a proper basis for the financial compensation of these special workers, will always be matters of serious care and concern."

Short Form: "The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern."

Understandably, we A.A. members are sometimes surprised to discover that the committees of our General Service Board, A.A. World Services Board, and the A.A. Grapevine Board recruit non -Trustee Directors who are selected especially for their expertise in certain fields. These non-Trustee positions do not represent any group or District or Area of A.A. Each of these trusted servants is chosen because they have deep expertise or specialized skill that is essential to the successful delivery of our world services. Bill wrote that, "The longtime success of our General Service Board will rest not only on the capabilities of the Trustees themselves; it will depend quite as much upon the competent leadership and harmonious association of those non-Trustee committee members, corporate service directors, executives and staff members who must actively carry on A.A.'s world services."

Getting the right people with the right knowledge to work in our General Service Office and to sit on our board committees is extremely important to our Fellowship. The Nominating Committee of the General Service Board "aids the Trustees in discharging their prime obligation to see that all vacancies whether within their own ranks or among key service directors, executives, staff members - are properly filled with members and workers of the greatest possible competence, stability and industry." We should never shy away from appointing or hiring experts. We need the most proficient professionals in roles that require great specialization. This is true whether we are seeking public relations leadership, experience in financial (communications), highly-trained editorial expertise, or knowledge in an emerging field of cutting-edge technology. We must perform our A.A. world services in the real world. To do that effectively, we need to make sure we are staffing our committees and our office with the best talent possible.

Concept Eleven offers guidance about how the Trustees can get the expert help they need to do all that we've asked them to do. If that help comes from a non-Trustee Director on one of our two corporate boards, A.A. World Services, Inc. or The A.A. Grapevine, Inc., then we should choose these Directors with an eye to their relevant professional experience so that they are of maximum service to the Fellowship. When we form committees, we should pay attention to the expertise, experience, and leadership qualities of the trusted servants we appoint to each committee. When we hire staff people for the General Service Office or The A.A. Grapevine office, we should recruit the most talented and dedicated individuals possible. And Bill goes on to say that we should pay them well to do the great amount of work we ask of them. To honor our spiritual principle of keeping the common welfare of A.A. first, we must take care to choose the very finest, most productive, and highly-principled trusted servants for each position.

It's true that no expertise is required to get sober and successfully recover through the Twelve Steps. However, the larger work of carrying our message through our world services and throughout our general service structure sometimes requires highly specialized skills. As a Fellowship, it is our collective responsibility to always seek out and support the expertise we need to be the most successful in reaching other alcoholics.

The Twelve Traditions - How they apply in our lives

TRADITION ELEVEN

"Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and films."

The long form of Tradition Eleven reads as follows:

Our relations in the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not to be broadcast, filmed or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.

Early in my A.A. membership, everything was about me. The steps and the traditions were words on the wall and I had yet to digest the full Twelve Steps or embark on the Big Book, let alone be concerned with the business of the traditions. It is not surprising I read the words on the wall in an individualistic and personal manner. I read that every A.A. member should be anonymous and each would do me the same favor. It is true that many outside the Fellowship do not understand the disease of addiction, the true underpinnings of the program and often have biases that could jeopardize our jobs, families, egos, etc.

I believe that for these reasons and likely dozens more, people within the program should choose their own openness about membership beyond those in the Fellowship. I think it is a common courtesy. I also believe that someone else's story is not mine to tell in whole or part. I respect and guard people's personal anonymity and believe it is crucial for many having the courage to join and stay with the program. However, I have come to understand that this is not the crux of Tradition Eleven.

Tradition Eleven suggests that many of us — without cause for restraint — would become zealots in the promotion of the solution we have found. In the early days of A.A., they found that depending on who and how this promotion was done, more damage could ensue than good. Likewise, the press was better equipped to promote the cause than we were ourselves. Many in the promotional business (press, radio and film) added weight to the message through the rigor of investigation and skepticism. They were (and largely remain) quite willing to edit names, photos and other identifiers on our behalf.

With regards to this Tradition in my own life, I focus on two things today; attraction versus promotion and my own ego. When I entered the program, there were a lot of well-meaning people telling me what to do and how to recover (most with no education or experience to do so). I am no more able to tell someone what to do with any authority. And who would have cause to believe me beyond my personal experience, strength and hope?

More importantly, I am reminded that personal ambition has no place in A.A. I come to A.A. on the level with everyone else. If I have a spiritual life that has granted me a few 24-hour periods, it is because I have stood on the shoulders and encountered the embrace of those who came before me to carry the message. Our predecessors found that this was the most effective evangelism we could pursue and I am grateful that this is one of the Traditions that has enabled A.A. to endure as a solution until I needed it most.

part, while doing my day. How can I be peaceful, quiet, contented, relaxed, loving, tolerant and patient while being of service to those about me, while doing my job for my employer, while participating in my relationships?

Once I get to this part, I usually am able to start to focus on my breathing, (one of those things I picked up along the way) and really begin to let go of the results and expectations for the day and deepen that conscious contact with the Great Presence.

It is interesting sometimes how I can't quite get to that peace of mind that I am searching for during the actual meditation. When this does happen, I find it kicks in later, like a delayed reaction. Sometimes in 15 minutes, sometimes in an hour, but the peace of mind and the flow that comes with it eventually does kick in.

I have gone through periods of sobriety where prayer and mediation get neglected. It is usually because it doesn't seem as important because life is going good. I invariably don't set aside time to do it and rush into the world. Those periods are fraught with anxiousness, edginess and a short tolerance for other drivers on the road. When I do come back to it, I find that I cannot sit still for even a five minute session. It is like me trying to do a 300 pound bench press after not having been to the gym for a year. Not going to happen. (Just to be clear, I have never benched even 225.)

So I start off small and build up my prayer and mediation "muscles" to regain and improve that conscious contact.

So back to the question of why? Simply, life just seems to go and be better.




