Step Twelve

"Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs."

Why did I relapse? What happened? What will be different this time? All of these thoughts raced in my mind as I struggled to make sense of my recent short, but painful, relapse. Nine months sober, newly relocated to the Twin Cities, and making many choices based on self, I had placed myself in a troubling position. In some respects I was checking the boxes of "good" recovery. I had previously worked the steps, I had a sponsor and I usually attended my home group. Despite these efforts, I was brimming with resentment and fear. After several months of "white knuckling" it, the mental obsession had won. Hung over and terrified the next morning, I called my sponsor and I became willing. "The gift of desperation" set in, but what was I to do to ensure against another relapse? What had been missing in my program the first time?

The answer to these questions was not immediately apparent, but I was in enough pain that I did what I was told – kept going to meetings, prayed, asked for help, and raised my hand to sponsor other women. As days turned to months of sobriety, I still felt unsettled and awkward at meetings, as in life. But, at the stern prompting of my sponsor, I kept engaging newcomers to welcome them and see if they were in need of someone to take them through the steps. Persistence and willingness paid off, and soon I was plodding through the pages of the Big Book with several sponsees.

As I sat across the table from each newly sober woman, I found myself forgetting my own discomfort. When I suggested that she go to the meeting *whether she felt like it or not*, I found it easier and easier to attend *every* week myself. While I read and re-read the instructions as outlined in the Big Book, I heard new promises. Work with these women has proven to be the "missing piece" of my recovery. I had not been consistently carrying the message when I relapsed – finally, something I could do differently! And, indeed, Twelfth Step work has been a central factor of my sobriety for the past six years.

Carrying the message is but one component of Step 12, which has three parts: (a) having had a spiritual awakening as the result of these steps, (b) we tried to carry this message to alcoholics, (c) and to practice these principles in all our affairs. The first portion begins with the foregone assumption that I have

already completed Steps 1-11. This is no small task, and I am grateful to the many women who have spent countless hours taking me through each one of them. If that step work is in place, Step 12 states that I will have had a spiritual awakening. Many descriptions of "spiritual awakening" are available, and my favorites are often those shared at meetings. I was recently reminded that my behavior change is a clear indicator of having had a spiritual awakening. I hope that my spiritual awakenings keep happening, and that my reactions to life continue to become softer and kinder over time.

Step 12 then takes the very action that was required for a spiritual awakening and propels it forward in part (b). I am asked to "try to carry this message to alcoholics." For me, participation in this part of Step 12 has been a turning point in my

Notes from Your Board Chair:

As we all watch the changing of the seasons, we also know that the holiday season is fast approaching. Depending on where I have been along my own journey of recovery, the holidays have brought tremendous joy, sadness, or even both at the same time. This is true for most any alcoholic during the holiday season and can be especially challenging for the newcomer.

My first holidays in sobriety were spent living in a sober house away from any family or friends. I heard that staying busy would benefit me, so I went to various AA meetings all over the Minneapolis area. I stayed late and participated in activities before and after meetings, especially when I did not want to - I began to feel at home and safe.

Despite often feeling sad, frightened, and uncomfortable in early sobriety, I began to gain a sense of love and belonging in those meetings as I was taken in by this Fellowship. One thing that surprised me in early sobriety is that many meetings still take place on the day of a holiday. I began to see that AA shows up no matter the holiday and that I could rely on it to be there when I needed it.

Since that first year in sobriety, I have practiced, to the best of my ability, the actions that other AA members

and my sponsor have suggested during holidays spent with family. I have contributed and been of service wherever possible to them, and I am grateful it has been possible for me to show up in this way because of the AA program.

After having been blessed with several years of joy-filled holiday seasons in sobriety, I experienced a heartbreaking holiday season last year with the passing of my 64-year-old mother/best friend on December 3 after a short fight with cancer. During that time, I truly learned what “life on life's terms” meant, and I stayed in the middle of AA as best I could. Because of this, I stayed sober and was able to serve my family when it really mattered. This year I am feeling many emotions about the upcoming holiday season, and I plan to dig in to AA again just as I did during my first year of sobriety. I will be missing a very big part of my life now that my mother is gone, but I know where I can go to feel loved and supported just as I did when I was newly sober.

If you find yourself in a tough spot of any sort during the holidays, there are many events and meetings available. Give the Intergroup office a call anytime, 24 hours a day, if you are looking for information on a meeting, event, or are interested in volunteering to help the still-suffering alcoholic.

Twelve Concepts for World Service, written by Bill W. in 1962

Concept XII:

Long Form: "General Warranties of the Conference: in all its proceedings, the General Service Conference shall observe the spirit of the A.A. Tradition, taking great care that the Conference never becomes the seat of perilous wealth or power; that sufficient operating funds, plus an ample reserve, be its prudent financial principle; that none of the Conference Members shall ever be placed in a position of unqualified authority over any of the others; that all important decisions be reached by discussion, vote, and, whenever possible, by substantial unanimity; that no Conference action ever be personally punitive or an incitement to public controversy; that, though the Conference may act for the service of Alcoholics Anonymous, it shall never perform any acts of government; and that, like the Society of Alcoholics Anonymous which it serves, the Conference itself will always remain democratic in thought and action."

Short Form: "The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and whenever possible, substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government; that, like the Society it serves, it will always remain democratic in thought and action."

In the past year there are two issues affecting A.A. that have drawn many members to read and re-read Concept Twelve closely – first, legal action by the General Service Board attempting to regain possession of a 1939 original printer's manuscript of the book *Alcoholics Anonymous*, and second, a request by the General Service Board for feedback from the Fellowship about what measures might or might not ever be appropriately taken to protect A.A. intellectual property rights. This question has arisen because an outside entity is using the name Alcoholics Anonymous in conjunction with a commercial website.

The reason these two issues draw us to Concept Twelve is because it holds the Warranties of the Conference Charter. (The full text of the Charter can be found in *The A.A. Service Manual*.) The first article of the Charter sets up the General Service Conference as "the guardian of world services and of the Twelve Steps and Twelve Traditions." This is a serious responsibility. The Warranties offered in article twelve of the Charter are a set of principles to help guide the Conference in that role. To follow these principles is to guarantee that the Conference is acting within the spirit of the Twelve Traditions.

Regarding these two legal matters, Warranties Four and Five provide guidance. Warranty Four states "that all important decisions be decided by discussion, vote, and, whenever possible, by substantial unanimity." In the printer's manuscript matter, the General Service Board chose to act without first seeking discussion and a vote of the Conference. It was clear at the Conference in April that acting without consulting the Conference

first was at the core of many groups' and Areas' concerns about the matter. There was no chance to have input regarding what turned out to be a very expensive undertaking that ultimately failed.

The General Service Board certainly heard the Fellowship's collective frustration about not being consulted in important matters. At the same conference in April, the Board directly asked the Delegates for input regarding the intellectual property question. Since then we have done our part to discuss the topic in our Area and many members have looked to Warranty Five for insight. While the Warranty itself is not explicit about the appropriateness of taking legal action, Bill's writing on Warranty Five states "that a public lawsuit is a public controversy, something in which our Tradition says we may not engage." That would seem clear cut if there were not also other warnings in the same essay about the need to protect the name Alcoholics Anonymous above all else. The issue will clearly need more debate and discussion by the next General Service Conference in order to give our General Service Board clearer guidance. Wisdom from Concept Twelve will be fully reviewed and discussed in that process, for sure.

ability to stay sober. As Chapter 7 of the Big Book states, "nothing will so much insure immunity from drinking as intensive work with other alcoholics." I have found this statement to be true time and time again. I have made (and will continue to make) many mistakes in my recovery, but I have *never* gone wrong to spend time in the Big Book with a newcomer. Every time I sit at my kitchen table with a new woman, I learn something from her. Every time I hear her experience and share mine, I am reminded why drinking is not a good idea for me.

I have been taught that as I remain willing, God will give me the Twelfth Step work I need. The "Twelve and Twelve" explains that Twelfth Step work can be carried out in a variety of ways – making coffee, greeting others at the door, or even participating in meetings. While I find sponsorship to be the most rewarding version of Twelfth Step work, I am grateful that my ability to carry the message is not limited to this type of relationship.

The last part of Step 12 asks me "to practice these principles in all my affairs." I was initially quite overwhelmed by this suggestion, thinking it intended for me to strive for perfection in all of my relationships. It has since been pointed out to me that this seemingly tall order is quite attainable when correctly read, "*try ... to practice the principles,*" and that the word *perfect* is not part of the instructions. I am now able to practice the principles in my marriage by working the Traditions as they apply to our relationship. I am able to practice humility at my work. I am able to practice tolerance for opposite points of view.

When asked what is different in my recovery this time, I am grateful to respond "Step 12!" This step allows me to connect with my Higher Power and with others. It gives me concrete actions that always work for me. When I show up and work with others, I feel better. When I feel better, I don't find a drink necessary.

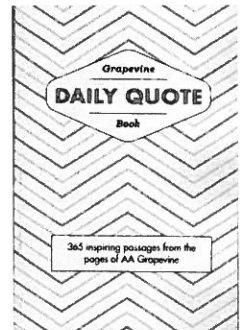
