### January 2019 Step, Tradition, and Concept One

# Step One

"We admitted we were powerless over alcohol - that our lives had become unmanageable."

Confronted with the reality of being evicted from my third house in as many months, I found myself trapped. Not because I was being evicted or kicked out of my house, that was nothing new to me, it was because I could no longer see a way out. I had no plans I believed would help me find a new place, no bright ideas to win back the relationships I had lost, no fight to do better. Here I was, at 19 years old, homeless, jobless, every bridge in my life burned to the ground, and no booze to last me through tomorrow. All of my hopes of a better life came crashing down in that one instant, and thank God they did. In that split second, when everything was crashing down around me, I had a moment of clarity and called my mom. "Hey mom, I think it may be time I go to treatment." "You're allowed home for three weeks while we work out where you go. Bye." As soon as the conversation ended, a thought raced through my mind, "what have I done?" This simple phone call led to a series of events that eventually brought me to the rooms of Alcoholics Anonymous. In the rooms of Alcoholics Anonymous a sponsor reached his hand out to me and gave me the gift that was given to him. This sponsor took me through the 12 Steps and I've been blessed to do so with others. Through working the 12 Steps much has changed, however, one thing has remained. The reason I am an alcoholic. Am I an alcoholic because of the times I would get in street fights at 3 a.m. on a Wednesday morning after drinking all day? Is it because of that time I woke up handcuffed to a hospital bed after drunkenly fighting a security team? Is it because I would go home every night and lay in my own vomit after drinking for days on end? Experience has shown me the answer is no. I am an alcoholic because of the times I went home after getting into a street brawl, thinking to myself, "I'm never going to do that again," and the first thing that would happen when waking up was down another shot of vodka. It is the time when I left the hospital where the thought of being sober for more than a moment drove me to grab a bottle and down as much of it as I could manage. It is the time after waking up soaked in blood, puke, and shame; thinking this won't happen again and being drunk two hours later without a second thought. The

powerlessness of alcoholism isn't in getting drunk and getting in trouble. It lies in those moments where with every fiber in my being and every modicum of self will at my disposal, I would still end up drunk. When everything was on the line; a new job, another chance with my girlfriend, my parents letting me back into their house, getting back to school, I would find myself drunk and hurting again. There is a passage in Alcoholics Anonymous' basic text that reads, "We must concede to our innermost selves that we were alcoholic." Looking back on the phone call with my mother, I had the realization that I was different than others, I could never quit drinking, and that my life would continue to spiral out of control. The helplessness when faced with these truths was overwhelming, for the first time in my life I had felt despair. My experience has shown that the First Step isn't a step of hope, in fact it's the opposite. The fact of my life is that I am and will always be an alcoholic. When left to my own devices life can and will spiral out of control, and I will drink again. The utter powerlessness and hopelessness of my situation was smashed home, in essence, my First Step experience. I am not, nor will I ever be, the solution to my alcoholism, but there is a place that showed the way out of the pit of despair. For that I will forever be grateful to Alcoholics Anonymous.

Yesterday's World - Our Legacies Begin.


Today's World – Demonstrating Integrity, Anonymity and Service.



# Twelve Concepts for World Service, written by Bill W. in 1962

### Concept I:

Short Form: Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole fellowship.

The A.A. Service Manual tells us in Concept I that Bill W. transferred the responsibility of AA's world services to the whole fellowship at the St. Louis International Convention in 1955. Bill also tells us why and by what authority it was done.

A.A. membership was growing by leaps and bounds. By 1950 the Twelve Traditions had been adopted for the groups to survive. But on the whole, the fellowship worldwide was still counting on Dr. Bob and Bill W. for advice and guidance. When the idea was suggested to turn over the world service to the fellowship, there was push back from A.A.'s Service Headquarters. The Trustees of that time and the fellowship as a whole really did not communicate unless through Bill and Bob. The Trustees felt inviting Delegate's from all over the country would cost money and the possible introduction of politics into our fellowship! The average member of Alcoholics Anonymous was busy with their own Group's business and Twelfth Step work. Some didn't even know that Trustees existed.

But, then Dr. Bob was diagnosed with a fatal illness. He and Bill realized that they were not going to be around forever. The gap between the fellowship on the whole and the Trustees had to be bridged if AA were to survive!

Bill also refers to Tradition Two in Concept I which states, "For our group purpose, there is one ultimate authority-a loving God as He may express Himself in our group conscience. Our leaders are trusted servants; they do not govern." The groups are the authority, delegating responsibility. It is the collective experience of the Groups.

My personal experience is this: if you give me authority without responsibility, it will not go well! I was invited, and so went to a lot of Service Conferences and functions way before I was elected into any service position. When I was elected as General Service Representative for my home group (the Third Tradition Group in Northfield), I already knew what my group expected of me. I was to become fully informed at the District and Area, bring that to my group and take back our conscience. I was not to skip District or Area meetings. I was not at Area and West Central Regional functions for a party or a break from family life. I was to sit in, at the time, uncomfortable chairs all day and take notes. I need to bring back a full report to the Group upon my return and explain if I voted differently than they had asked

me to. They were giving me the responsibility with the authority! Maybe they just knew how sick I was!!

I don't know if Delegate's give you questions to ponder in these articles, but here goes anyway:

Do you personally take the time to find out what you are a part of outside of your home group? Do you take the time to explain to your sponsees what they are a part of and challenge them to learn about of our history?

Thank you for allowing me to be of service in Area 36, it truly has kept me in the middle of Alcoholics Anonymous and has saved my life! And I am truly honored to represent you in May at the next General Service Conference in New York!

# The Twelve Traditions - How they apply in our lives

### TRADITION ONE

"Our common welfare should come first; Personal recovery depends on A.A. unity."

Tradition 1 suggests that the welfare of our fellowship is based upon our ability to unify in purpose and principle. It also suggests that our individual recovery depends upon that unity.

When I was first asked to write a little something on this tradition, I began to think about how this tradition has impacted my sobriety. I began to think about how I practice the underlying principle of this tradition and how I could grow in practicing this tradition.

I witnessed this tradition in action for the first time when I was newly sober. I can't recall the details, but I remember clearly the heated discussion among homegroup members at a business meeting. I can picture in my mind's eye the loud voices, red faces, bulging veins. Then they took a vote. The meeting was adjourned, and everyone walked out of the room together laughing and joking just like they did before the meeting. Back then I remember thinking, "Boy, I belong to a group of crazy people." Now I know what I witnessed was the practice of Tradition 1. Each member of the discussion clearly felt strongly about their position and was not afraid to voice it. Passions ran high. Each member was heard and a vote taken. Once the vote was taken, I had the privilege of witnessing everyone setting aside individual feelings and what they thought was best for the fellowship, for the collective idea of what the group thought was best for the fellowship.

On a personal level, in hind sight, I had left a trail of broken relationships, because of my inability to practice this principle. I was always trying to get people to see things my way, to understand me, to listen to me, to do what I wanted to do. I always knew the best and most efficient way to complete a task. I could lead and I could follow but never be "one among many." The way I saw relationships was—winners and losers. This tradition suggests that the welfare of the relationship is more important than my individual perception, idea or wish. It helped me tremendously when my sponsor shared with me how she and her husband make decisions together. If they come together in agreement — great. If they do not agree, action is deferred. They both step back and try to see what is best for their group of the two using the tools AA gives us —

inventories, prayers, sponsors, etc. When an agreement is reached, not based on their individual desires but what is best for their "group," they proceed. Based on her experience, I began to practice this tradition not only in AA but with family, friends and at work. It appears to me that the better I am at practicing this tradition, the better my relationships are. The better my relationships are, the better I am.

The practice of Tradition 1 helps alcoholics like me to not only participate in the fellowship of AA (which my life depends upon), but also gives me a fighting chance to develop and maintain other relationships (family, friends, work). Thank you for allowing me the opportunity to share a few thoughts on Tradition 1.






