Step Seven

"Humbly asked Him to remove our shortcomings."

When I first read this step, I really didn't understand the full meaning of it. I almost considered it one of those fly over steps. You know, well this will be easy after the 4th and 5th steps. In a way, it was easy for me at that time.

The 4th and 5th are steps where I discovered my liabilities shortcomings and not many assets. I approached this step with a sponsor and was more than willing to receive any help, even from a higher power that I didn't fully understand. If you don't have a clear-cut idea of those shortcomings after the 4th and the 5th step, I might suggest you take a harder look at yourself and actions.

The prior 6 steps are designed to strip away age-old layers of denial, ego, self-centeredness that consumed me and my whole life while drinking. I became fully aware with help of my sponsor that this step was far from a fly over step. I had to be ready for my God to help me remove these shortcomings.

I actually made a simple list of them and spent some time discussing them with my sponsor and I was not a happy camper by any means. I look back to those days and realize humility for me has a heavy price. With step 7, I began to realize that I had to stop looking at what I could get out of life and start looking at how could I contribute to others.

In the Twelve and Twelve it is stated, "the attainment of greater humility is the foundation principle of each of AA's twelve Steps". So, to me, this is another opportunity for us to embrace the pursuit of humility as a fundamental aspect of staying sober. None of these shortcomings left me without work. But eventually, they did. Progress not perfection. Oh, and believe me, I also have the ability at any time to take all or some of them back. I have to stay right sized in my life. I have to remember the essence of the "Seventh Step Prayer". "My creator, I am now willing that you should have all of me, good and bad. I pray that you now remove from me every single defect of character which stands in the way of my usefulness to you and my fellows. Grant me strength as I go out from here to do your bidding" Doesn't that say it all?? If we truly believe in our Higher Power how can we not be more useful to our fellows?

For me, this was just the beginning of obtaining relief from myself and becoming humbler and more useful to my fellow.

I'm constantly amazed at how far I have come, and yes, how much father I can go.

Bill W. couldn't have spoken a more profound virtue for me to live by in one of his talks in 1966. Taken from "As Bill Sees It" page 271.

"All A.A. progress can be reckoned in terms of just two words: humility and responsibility. Our whole spiritual development can be accurately measured by our degree of adherence to these magnificent standards.

"Ever deepening humility, accompanied by an ever-greater will-ingness to accept and to act upon clear-cut obligations—these are truly our touchstones for all growth in the life of the spirit. They hold up to us the very essence of right being and right doing. It is by them that we are enabled to find and to do God's will." Talk, 1965 (Printed In Grapevine, January 1966)

So, in closing, I can now honestly say, that Step Seven is in no way a fly over step. In fact, none of the other 11 steps are either. Although it's not long on words, it's long on wisdom for us alcoholics. Stay the course and keep your Higher Power and the Program close to you. Your reality will change, and your humility will grow.




Twelve Concepts for World Service, written by Bill W. in 1962

Concept VI:

Concept VII:

Long Form: "The Conference recognizes that the Charter and the Bylaws of the General Service Board area legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.

Concept VII lays out the "rules" for us to distinguish between the power of the Trustees and the power of the Conference. Checks and balances come to mind for me here. The Trustees have the legal authority and responsibility of World Services. The Conference (fellowship represented) has the ultimate authority and responsibility overall. The Trustees and Conference have the authority and responsibility to elect new Trustees as they see them fitting into the needs of the General Service Office and Structure of World Services. The Groups have the power of the purse to make sure that the Trustees are representing Alcoholics Anonymous as a whole. The "Power of the Purse" is easy to misunderstand and has been misunderstood in the past (in my opinion). I have heard AA members speak from the microphone that they are withholding funds due to unhappiness with GSO and the Trustees. They are perfectly within their right to do so. There are some who do not communicate with GSO and the Trustees as to why they are unhappy. That is when the full Power of the Purse is not understood. We need to let them know why we are unhappy so that they may make changes if needed.



The Trustees have authority over World Service but the Conference has authority over our service material. There was an Agenda Item (Literature I for us) that wanted to change A.A.W.S. policy giving authority to the Publishing Department to update our Pamphlets and other Literature. Our Area 36 Groups said no thank you to that Agenda Item. I voted at the Conference as the Groups asked me to. That Agenda Item went back to the Trustees Committee for updating of the Policy. With that said, yes our Literature needs updating!! So, I put that back on the groups to take that responsibility seriously and start making suggestions on how we update those. If it is our responsibility then we need to do it, or they will do it for us! I look forward to seeing all of you at your Districts Delegates Report.



TRADITION Seven

" Every A.A. Group ought to be fully self supporting, declinina outside contributions."

Tradition 7: "Every AA group ought to be fully self-supporting, declining outside contributions," is one near and dear to me because it's a main theme in my sobriety. "Whoever pays the piper is apt to call the tune..." (p. 164 Twelve Steps and Twelve Traditions). And that's exactly how I liked it. An only child, spoiled rotten and victim of life I blamed my parents for my unhappiness. I hated them because they called the shots and had zero respect for me. I was drunk, manipulative and lying about my finances so I could get more money from them. I couldn't take responsibility for myself and hated myself too.

In AA, practicing the 7th tradition changed all of that. Getting sober at 22, I still needed help from my parents, but slowly took on more and more financially. As time went on, I needed them less and less, and started developing a relationship of adult to adult. Through self supporting in my own life I became responsible for myself.

Now I love, appreciate and respect my parents for all they have done for me. Our relationship is no longer tense and it's actually enjoyable. I look forward to seeing them, and they look forward to seeing me too. They have more respect for me now that I respect them and respect myself. The best part is I'm proud of myself and feel good about my money management and decisions. Becoming self supporting was one more step towards walking in God's will and making a direct and living amends to my parents. The promise that "fear of...economic insecurity will leave us," (p. 84. Alcoholics Anonymous) has finally come true in my life. My higher power takes care of me when I take the right action toward it.











