## Step Eleven

*"Sought through prayer and meditation to improve our conscious contact with God as we understood Him, praying only for knowledge of His will for us and the power to carry that out."*

Some refer to Step's Ten, Eleven and Twelve as maintenance steps and I understand why. Through the actions of the first nine steps, the obsession to drink had been lifted and I was experiencing a degree of emotional peace. The truth at that time was that my newly found physical and emotional sobriety was fragile at best. How do I keep what I have? Is this it? What is God's will and does that include happiness? I have since come to understand the last three steps as growth steps. The more I incorporate Step Eleven in my daily life, the more I grow spiritually and my understanding of God. My will is what got me in trouble in the first place, but even with the knowledge of that, I was fearful to do what God intended for my life. I have found true happiness and serenity, when my will matches God's will. How do I pray?

When I first started working the steps with my sponsor, the whole God concept seemed like a major road block. I wasn't agnostic, but my concept of God was one of judgment and punishment a twisted view of my early religious perspective. I believed religion and spirituality were the same and that if the only solution for alcoholism was a spiritual experience and reprieve, I was damned because of all the carnage I had caused others in life. I was relieved to learn that I can start over with my own concept of God and that I can find a spiritual solution for my life without a strict religious code. My prayers were "fox hole" prayers and ones of bargaining. "God, if you let me get away unscathed from this sobriety check point, I will never drink again."

Presented with Step Eleven for the first time, I felt that I was already "working it". In reality, I was praying for my own will and no meditation. Early on in sobriety, finances were tough. I was digging out from years of bad choices and misunderstandings. I was separated from my wife and paying for two

households, two mortgages, back taxes, etc. and was quickly living paycheck to paycheck. Every morning I would get up and pray for strength and more money. "God, I'm doing the next right thing, I'm making financial amends, why won't you give me more money, do you want me to have a resentment?" I was miserable and starting to question if I would ever be happy. My sponsor suggested I work Step Eleven...pray only for God's will and strength to take the action.

"God, I don't have all the answers, you know my struggles, use me as you see fit and give me the power to carry it out." Every morning and every evening I prayed that prayer. One morning I arrived at work and had paid the last bills for the month. My car was on empty, I had no money for food and I had two weeks until my next paycheck. I was scheduled to chair a meeting that night and pick up two newly sober guys before the meeting. Fear was starting to take over and I was in full panic mode. I went to my car and prayed the prayer I had made earlier that morning and then sat waited for the anxiety to wain and for God to provide an answer....my first real experience with meditation. I returned to my office to find an envelope with a check and a note. My boss had written a note thanking me for being an incredible employee the last nine months (I had been sober for ten months) and that he had found an accounting error on my com-

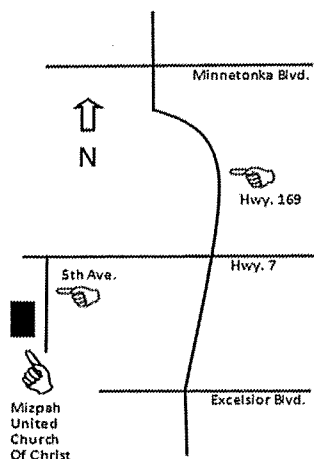

## Twelve Concepts for World Service, written by Bill W. in 1962

### Concept XI:

**Long Form:** "While the Trustees hold the final responsibility for A.A.'s world service administration, they should always have the assistance of the best possible standing committees, corporate service directors, executives, staffs, and consultants. Therefore the composition of these underlying committees and service boards, the personal qualifications of their members, the manner of their induction into service, the systems of their rotation, the way in which they are related to each other, the special rights and duties of our executives, staffs and consultants, together with a proper basis for the financial compensation of these special workers, will always be matters of serious care and concern."

**Short Form:** "The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern."

We have already talked in the last couple of months about whom it is that elects our Regional Trustees. It is our Fellowship. Our A.A. groups do through the election of the Delegate. But, our world services are not just taken care of by the trustees that we elect. They need help. Remember they are volunteers; they are not paid for their work as trustees. So, they obviously cannot put all of their time into world services as volunteers. They need a lot of help. The standing committee process that we use in Area 36 mimics the General Service Office. They must use a committee system to help them carry out the work that must be done. One of those committees is the Finance Committee. I had the privilege of being able to represent Southern Minnesota on the Finance Committee at the General Service Conference in May of 2019. I was able to work closely with the Chief Financial Officer, Bob and his assistant Zenaida. We need to financially compensate them for their expertise in dealing with the A.A. groups contributions. Bill says in Concept XI: The whole temper of today's world is to spend more than it has, or

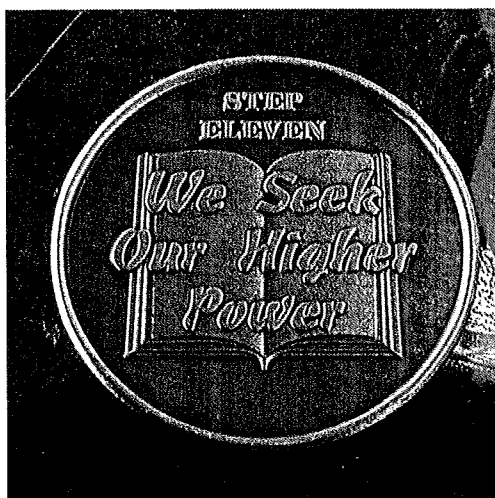
may ever have. When a new and promising A.A. service project moves into sight, we are apt to cry, "Never mind the money, let's get at it." This is where we need those special workers to say, "Stop, look and listen." So, the primary function of this committee, therefore, is to see that our Headquarters operation is always solvent and that it stays that way, in good times and bad. They are always keeping an eye on the budget that is made and will make adjustments when necessary.

There are other committees that are in place that we need. I can only give you a glimpse of one. Go get the Service Manual if you don't have one and learn what it is you belong to.

## **The Twelve Traditions - How They Apply In Our Lives**

### **TRADITION Eleven**

**"Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and films."**

The word anonymity means the condition of being anonymous. Anonymous is defined as not named or identified. I can certainly identify with the following statements: "By temperament, nearly every one of us had been an irrepressible promoter, and the prospect of a society composed almost entirely of promoters was frightening". "But we do have to soberly face the fact that being in the public eye is hazardous, especially for us." (page 181, Twelve Steps and Twelve Traditions). My promotion of the A.A. program started at a personal level. Imagine a relative's surprise when I sent him the Big Book of Alcoholics Anonymous, unsolicited, via Federal Express during my first few months of sobriety! I just knew this would help him and that the program of A.A. works. This promotion, after having only worked Step One myself, is embarrassing. This tradition steers me from the need for recognition for any positive changes in my life that have come from working the steps. Any desire I might have for public recognition is the opposite of humility. If I keep my head down and do the work to the best of my ability, I have a greater chance of appealing to others looking for a solution to their alcoholism.

At the level of press, I actively avoid the opportunity to be in a full-face photo or quoted by first and last name at the A.A. International Conventions I attend. (Luckily the press at these events has been schooled in our tradition so the occasion rarely arises). I do not write letters to the editors of newspapers proclaiming my knowledge of solutions to alcoholism and citing my membership in A.A. I do not allow my photos or comments to be posted on social media where the event is clearly labeled as an A.A. event or even a group of self identified A.A. members getting together for a social occasion. I strive to follow these guidelines outlined in the book Twelve Steps and Twelve Traditions: 1) Give up my natural desires for personal distinction before the general public because personal ambition has

no place in A.A.; 2) Understand that I am a active guardian of our Fellowship and that breaking this tradition could cause damage — especially if I got drunk. People would have cause to believe that the program of A.A. does not work; 3) Exercise self-restraint; 4) Realize that the spiritual substance of anonymity is sacrifice and real humility at work; 5) Appreciate that A.A. can publicize its principles and its work, but not its individual members.

I have since learned that prayer is often a one way conversation and meditation is the act of listening. I strive every day to talk less and listen more. There is an analogy I often give the men I sponsor when we work Step Eleven and they have a desire to brush it over. Years ago, I bought a nice 50 inch flat screen plasma TV but for one reason or another, I didn't have time to mount it on the wall. For weeks, I sat and admired that TV in the box. When I finally got time to mount it and I plugged it in, the picture was ten times better than the box. God of our understanding is the power source. We have been given a new life in sobriety, why would we just keep it in the box.
