April 2020 Step, Tradition, and Concept Four

Step Four

"Made a searching and fearless moral inventory of ourselves"

The spiritual path of recovery moves from Step 3; in which we offer ourselves to God, praying for relief from the "bondage of self" in order to better do God's will (3rd Step prayer) into Step 4. This is the first step which really required me to take some action.

One of the most impactful 4th steps I've ever done was through the Original 4th Step Seminar...this experience fundamentally changed how I look at and view this step. For years I've heard this step talked about with such trepidation, that I feel it has a way of perpetuating an underlying fear or uncertainty with regard to Step 4. Today, I believe it's nothing to be feared at all...but instead, that this step is just about looking at the stories of our lives, as the Big Book says, in "a fact-finding and a fact-facing" way.

The purpose of this fact-finding, fact-facing inventory is an "effort to face, and to be rid of, the things in ourselves which had been blocking us" (Big Book pg64). The question is blocking me from what? Blocking me from a Higher Power, from the Sunlight of the Spirit, or the GOD of my understanding. It really doesn't matter what I choose, but all I need to understand at this point is that the process will help me to be rid of the things which are blocking me. I believe it is difficult for the Sunlight of the Spirit to shine through me if I'm filled with Resentment, Fear, and Sex/Behaviors which are creating guilt/remorse/shame.

I began making lists starting with Resentments, then Fears, then Sex/Behaviors...identifying the stories in my life where these things were causing a spiritual malady within me. In all of these lists I identified People, Institutions, Principles, The Causes, The Instincts which were interfered with, and finally the exact nature. Through this process I was supported not only by my sponsor, but also by the seminar group itself. It was also pointed out in the seminar that this is a spiritual process and not a psychological process I was told over and over throughout the seminar to just "Trust the process"

This was all a process in seeing how SELF manifested in my life, and in ALL of these stories what was the exact nature, or in other words...my part. I had to take an honest look at where I had been Selfish, Dishonest, Self-Seeking & Frightened, and


Inconsiderate in all of my stories. In putting it all down on paper I was able to begin to identify certain patterns. The biggest of which was that in all of it I was the common denominator. Some of these decades old stories began to lose some of their power, perceptions began to shift, and I began to have the feeling or sense that perhaps a lot of my Resentments, Fears, Behaviors were of my own making.

The underlying principle of this step is Courage, and the process certainly required me to call on my Courage. But, not necessarily in the sense of what Courage has become synonymous with today...Bravery. But, Courage in the sense of the original meaning of the word. The word is derived from the Latin word Coeur (meaning Heart), originally meaning a heartfelt act.

It was helpful to not just bring my intellect to this process, but also my Heart. It seems that most of the spiritual world is contrary to my conventional wisdom. My best thinking would never have had me doing any of this 4th step stuff. I've heard it said that the most difficult distance I have to travel in all of recovery is the 18" from my Head to my Heart. If I'm going to make that journey, I better have a "God of my understanding", and "trust the process"

Minneapolis Intergroup is a service center for Alcoholics Anonymous. Our mission is to reach the still suffering alcoholic and help them find a solution for their drinking problem. What we also offer are opportunities for AA members to be of service. To me service is giving freely of yourself and not expecting anything in return. But we all know how that works, more times than not, we get more out of it than we give. For me, it is the difference between having quality sobriety vs. quantity.

We have a <u>group</u> phone commitment we need help filling. It is the 2nd Tuesday of each month at 7:00 pm to 9:30 pm. If your group would consider taking this commitment please contact any staff member from the office. We will provide an orientation for anyone who has not answered phones before. Some groups have had their service commitment for many years. The phones are not as busy as they have been in past years because of the internet and mobile access, but our phones being a 24 hour hotline is assurance when that one call comes in they will be welcomed to Alcoholics Anonymous by a live person.

We always need help with day time phone shifts. We have one shift from 9:00 am to 1:00 pm and another from 1:00 pm to 4:15 pm, each day Monday through Friday. If it's once or twice a month we could use your help.

In approximately six weeks we will begin our annual Outreach Program. Seventy groups are visited each year. There are two main reasons we do this. One is to bring the information about what Minneapolis Intergroup is and does. Some groups may know we exist but not know what vital services we offer. The second reason is to update our meeting directory. We get many updates from reaching out to groups. Each year as long as I have been here we have deleted two to four groups that no longer exist. This information helps our online meeting directory to have more accurate information for anyone trying to find a meeting, possibly *your* meeting. We will be presenting the information how best to do this service and assign you a group to visit on Saturday, May 4th or May 11th at 11:00 am after the regular Saturday Orientation meeting at the Mizpah Church in Hopkins.





Twelve Concepts for World Service, written by Bill W. in 1962

Concept IV:

Long Form: Throughout our Conference structure, we ought to maintain at all responsible levels a traditional "Right of Participation," taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each must discharge.

Short Form: "At all responsible levels, we ought to maintain a traditional 'Right of Participation', allowing a voting representation in reasonable proportion to the responsibility that each much discharge.

At out General Service Office there are paid staff members who help carry out the services that we have asked them to do. How did we ask them? Through our General Service Conference Agenda Items that our Delegates vote on using our Groups Conscience. Our Delegates are elected at each Areas Assemblies by our groups. We also have the opportunity to participate in the voting at the Conference and by electing our 8 Regional Trustees at the annual Conference. But the Area Delegates are not the only voting members at the annual conference. The other voting members are: the 21 Trustees, the Alcoholics Anonymous World Services Board Manager, the GSO Manager and the General Service Office Staff. The General Service Board Manager participates by appointing the elected Trustees to Committees that they will serve on. Those Committees can also ask staff members, paid executives or accountants to attend Board Meetings to give reports or advice on the items they are considering, which allows the staff members to participate as well. They are sometimes asked to act as Committee Secretaries during the annual conference. Before the Service Conference was started and the fellowship took on the responsibility of AA as a whole, the Trustees had most of the authority. But most of the leg work fell onto the Office where Bill and his staff took that on without any participation. They found that this was not going to work. And that is why we now have the staff members and Office Manager to carry out those duties along with their right of participation. I always wondered why they would have the right to vote, but after being at the Conference and seeing the whole picture it does make sense to me today. We need the final authority and the right of participation to follow up the responsibility that we ask of our General Service Office. It seems difficult to sum up these concepts in the words allowed by the Mirus. So, I really encourage you to read these Concepts for yourselves in the A. A. Service Manual. If you don't have one, go to your local Intergroup to buy one.






