Step Seven

"Humbly asked Him to remove our shortcomings."

Seventh Step Prayer

My Creator, I am now willing that You should have all of me, good and bad. I pray that You now remove from me every single defect of character that stands in the way of my usefulness to You and my fellows. Grant me strength as I go out from here, to do Your bidding. Amen.

The Seventh Step Prayer leads us into action. Step Six helps us to become willing to reduce our character defects, but at Step Seven, we are ready to jump in and give ourselves to the care of God. I like the thought of "giving" myself to God, good and bad. To me, it feels like we've come full circle. We actually came from God and were given our own will to live our lives. But we realize nothing good can come without God, so in Step Seven, we turn our lives back to God and give Her all of us that is good and bad. We, through Step Seven, realize that nothing good can come through us until we offer ourselves to God. It's comforting to give myself to God. In a way, it puts the responsibility onto God, and I can rest assured that She will provide and do the best with my good and bad traits.

In the next part of the prayer, we ask God to take away every single defect of character that stands in the way of our usefulness to Her. We have no idea what defects She will remove. Of course, we assume the "bad" defects will be removed. However, a defect we may think is good may be unuseful to God. For example, we may be generous people. But, put in the wrong circumstances, our generosity could actually harm someone that needs to learn responsibility. We don't know which of our character defects stands in our way of usefulness to God, so we put all of our defects into God's hands and ask Her direction.

Finally, we recognize that without our defects, we may be vulnerable in our coping skills to live in our world. So, we ask God to give us the strength to do Her biddings. The Step Seven Prayer is a complete request. It starts with our action of giving ourselves to God and ends with a request for strength to live our lives in doing God's bidding.

Twelve Concepts for World Service, written by Bill W. in 1962

Concept VII:

Long Form: The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.


Short Form: The Conference recognizes that the Chief initiative and active responsibility in most world service matters be exercised by the Trustee members of the Conference acting as the General Service Board.

What this means to me is that although the Trustees have the authority over World Services, it is ultimately the Groups that give them the money to act on our behalf as Alcoholics Anonymous.

So, where is the meeting ground for that exchange? It is the General Service Conference. I have had the privilege of being apart of the Conference on behalf of Area 36 for the last two years. This last year was such a new experience that no other Delegate has had. Will they have it again. I hope not! It was not the experience that I had last year or have had other Delegates describe in the past. Did we get some work done? Yes! But I would argue that face to face is the best option if possible.

I would also caution Groups to really discuss and pray when using the "Power of the Purse." When we use the Power of the Purse, we are not just affecting the Trustees. We are also affecting the General Service Office, its staff. With the coming of COVID19 this year, I have seen how low contributions can affect the Office. They have been working from home and therefore the General Service Office has had to buy a lot more equipment to keep our services as uninterrupted as possible. They have been working as if they are at the Office and answering emails daily. I can tell you some good news, the usual May contributions have been around 520,000 in the past. This May they saw over 800,000 with the start up of Pay-Pal on the website! So, the Groups are stepping up!! Thanks for letting me a part of the Conference on your behalf!! It has been a wonderful experience!

The Twelve Traditions - How They Apply In Our Lives TRADITION SEVEN

"Every A.A. group ought to be fully self-supporting, declining outside contributions."

Fully self - supporting was a foreign thought for me when I arrived in Alcoholics Anonymous. My finances were as chaotic as my life and my drinking. It took some time until I was living this tradition in my own life and it is still a challenge today. Even though the thought process is challenging the big difference is I am responsible and pay my bills monthly. I was surprised that the seemingly small contributions made by individuals weekly in the basket could be enough to pay our meeting's monthly obligations and have enough left over to contribute to the entities. The principle that we only maintain a prudent reserve and contribute the rest keeps the money issue very simple. When I have shared with others outside of Alcoholics Anonymous that we are self-supporting they are surprised to say the least.

The last few months with covid19, zoom meetings and venmo contributions each meeting of AA has been provided with a new challenge financially. Contributions have not been as forthcoming and we have all had to make an extra effort to "put money in the basket" via whatever means our meeting has arranged so that we continue to be financially responsible. It takes an extra effort for every member to remind ourselves that we need to continue to be self - supporting with in our meeting and also with the entities. If we don't continue to support our home group financially, we will not be able to meet our obligations and our local AA Intergroup office would also be affected financially. Individual meetings are discussing our obligation and responsibility to the church or building to whom we pay our rent. This tradition forces to think about and talk about finances responsibly.

We have learned how to be financially responsible personally but also to those that depend on us.

I challenge myself to continue to contribute and to increase that contribution accordingly. Being an active member of my home group means financially supporting my home group. Serving as a current Intergroup Board member I have been able to see first hand what self-supporting looks at the local Intergroup level. We are financially sound which prepares us for an unusual time such as the one we find ourselves in currently. Because we are financially sound we can focus on our primary purpose, which is to carry the message to the still suffering alcoholic.


