

April 2021 Step, Tradition, and Concept Four

Step Four

"Made a searching and fearless moral inventory of ourselves."

It was July, 1986. I was 4 months sober and running a race to prepare for the Twin Cities Marathon. This would not have occurred to me 6 months earlier, as I was still drinking, isolating, and hitting bottom. At 4 months sober, I was in aftercare, feeling desperate to find ways to turn off that urgent, alcoholic energy without using. For me, that meant AA meetings, fellowship, finishing aftercare and running.

I checked into treatment after a suicide attempt turned to a DWI arrest. The St. Paul Detention Center's overnight stay was courtesy of my first higher power, the highway patrol. Have you ever drunk yourself sober? I could not walk straight or talk without slurring. But that night, I clearly understood the situation as they put me in my cell. I was not scared or embarrassed. I was relieved. Someone or something else was taking over.

I am not sure that I wanted to die. The honest truth is I really wanted to stop the pain. By working the first few steps, I began to believe that I could actively choose to die, not die, or live. And I could live with the God of my understanding, and the help of strangers - fellow AA members.

I was willing to do whatever I could when I arrived in treatment. We were asked to do a fourth step. I began writing from the blueprint document and the Big Book they handed me. I was in early sobriety, but I was as honest as I could be at that time. I sensed that if I was going to survive and thrive, I needed to take the next actions.

Quiet reflection on past thoughts, words and deeds was a challenge. It was so easy to confuse myself, feel ashamed, and blame others. I began to question the wisdom of meeting with the treatment "holy man" so soon. To be honest, my first fourth step was really a very thorough first step. It taught me a lot about myself, my part, and began to prepare me for a sponsor guided fourth step in the future.


Fortunately for me, the steps are in an order for a reason. I was having trouble trusting God or anyone else to really help me do a fearless and moral inventory. I had taken care of myself for so long, regardless how poorly, and was struggling to turn it over. I knew I did not want to go back to where I had been. And I wanted to stop time so that I didn't have to choose. But neither life nor sobriety work that way. So, my only path could be steps forward – even shaky ones – one day at a time.

Looking back, I realize that learning to run was a similar journey to doing a good fourth step. I worked at learning to slowly jog and eventually run longer distances with ease. This was possible because I asked for advice and support from more experienced runners. They suggested corrections for my running "style" and provided tips on non-running activities to be more fit and capable. They advised me to not compare myself to others. If I had to compete, they suggested I 'compete' with myself, with my higher power's help, to get small and steady improvements.

I watched myself slowly improve those first few years – in running and sobriety. I was learning to trust others, including my higher power. I was fighting others less frequently, and learn-

Years ago, I volunteered to be the Intergroup
Representative for my home group, without much
information as to what I was signing up for. My first Rep
meeting was a huge surprise to me, seeing so many
people being active outside of their home group. It didn't
take long to understand what was going on. I found out
that all I had to do was attend the meetings, listen, take
some notes and report back to my group what was going
on. I could do that!

By having an Intergroup Representative at the meetings, groups can stay connected with what is going on at Minneapolis Intergroup and find out what service opportunities are available to help AA members find meetings, assisting newcomers in the program of Alcoholics Anonymous, keeping the telephone hotline available 24/7, and many other vital services. Reps can also share information about their own group's activities and events.

One important function of the Intergroup Rep is to cast their group's vote at the annual Intergroup Board election, on the $4^{\rm th}$ Thursday each September, electing four new Board members to serve a three-year term. Intergroup Reps receive resumes from the Board applicants to take back to their groups where a decision can be made as to which candidates they want on the Board.

Currently, 73 groups attended from all over the Greater Minneapolis area. 102 members have registered as a group Rep or Alternate Rep. All groups are welcomed and invited to participate at Intergroup.

Does your group have an Intergroup Rep? If not, we invite you to have this service position at your group and have someone attend our next meeting on April 22nd. Feel free to call Intergroup of you have any questions.

Twelve Concepts for World Service, written by Bill W. in 1962

Concept IV: Throughout our Conference structure, we ought to maintain at all responsible levels a traditional "Right of Participation," taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each must discharae."

Participation is a key to our success in Alcoholics Anonymous. The individual A.A. member needs to participate in recovery, the group participates in the unity, and we all participate on some level in service. The principle is so important that it was built in to our Conference structure as well. The "Right of Participation" it might best be explained in the context of who makes up the Conference structure.

The Conference is composed of area delegates, the trustees of the General Service Board, directors of A.A. World Services and A. A. Grapevine, and staff members of the Grapevine and General Service Office. Each identified role brings its unique viewpoint to the Conference and each one has a vote.

Area delegates represent the membership-at-large of Alcoholics Anonymous. They are A.A. members who bring the viewpoints of their geographic area. Some are metropolitan, others are rural, while others are in extremely remote areas such as Northern Canada. They carry with them their own experiences as alcoholics, the experiences of their groups, and the experiences of the groups in their area. Each has one vote on every item that comes before the conference. Since there are ninety -three areas, the membership has ninety-three votes.

The General Service Board is concerned with everything happening inside and outside A.A. that may affect the health and growth of the movement (from the A.A. Service Manual). They provide continuity and leadership in the same way that other boards do. But our board is largely custodial in nature. They oversee the work of our two operating corporations A.A. World Services, Inc. and A.A. Grapevine Inc. The oversight they provide gives them a perspective that is different from the area delegates. They have more of a "big picture" view. There are fourteen alcoholics (Class B) and seven non-alcoholics (Class A) and they bring varying backgrounds and talents to their service in Alcoholics Anonymous. They have twenty-one votes. Then there are the General Service Office Staff Members. They

Then there are the General Service Office Staff Members. They help with group problems by sharing G.S.O.'s store of accumulated A.A. experience through extensive correspondence and

telephone calls, and by traveling on request to A.A. events. Each staff member has a subject assignment (such as literature, public information, international, treatment facilities, etc.) which rotate every two years. Most staff members also handle correspondence for a geographic area. You have to be a member of Alcoholics Anonymous to be an A.A. Staff Member. (As a point of local trivia, two previous managers of Minneapolis Intergroup went on to be G.S.O. Staff Members.) Staff Members are literally working on the front lines for A.A. They are intimately involved in the daily operations of our world services so they bring that perspective to the Conference. They have 15 votes.

In forming the service structure for Alcoholics Anonymous, it was decided that these separate and unique perspectives all had a particular value that was important to making decisions for the good of A.A. as a whole. Each has an equal vote. We value each perspective and the experience it brings to bear on the future functioning of Alcoholics Anonymous. It's a radical approach but it works.

As the delegate for Area 36, I represent the membership of Alcoholics Anonymous here in Southern Minnesota and in the world at-large. Not everyone fits clearly into the description of "Right of Participation" described in Concept 4, but everyone is invited to participate in the process. You can participate by submitting an idea to your group, the district, or directly to the General Service Office for consideration at the next Conference. You can attend a Regional Forum to meet General Service Office staff and General Service Board Trustees. There you get the opportunity to learn more about how they are serving us as custodians of our fellowship. You and your group can also participate by sharing your opinions and feedback on agenda items. All of these actions are important in making our structure successful. With this in mind, please plan to attend the (virtual) Delegate's Workshop on March 27th.

The Intergroup Representative

A Link between your Home Group and Greater Minneapolis Intergroup

What is an Intergroup Rep?

The Intergroup Representative is your Home Group's voice for assuring that your Intergroup Service Office functions and carries out its Primary Purpose. All AA groups are welcome to participate at Intergroup.

What is the Primary Purpose of Intergroup?

Our main purpose is to help alcoholics find AA meetings and assist newcomers in the recovery program of Alcoholics Anonymous.

Intergroup's VITAL SERVICES

- 1. We answer our Telephone Hotline Service 24 hours a day to assist new members with the help and hope of AA
- 2. We stock all AA Conference-approved literature and other books for the AA community
- 3. We maintain an office to facilitate 12 Step calls and service opportunities
- 4. We maintain a web-based meeting directory which is updated weekly
- 5. We publish a print meeting directory at least once annually
- 6. We publish the MIRUS newsletter every month
- 7. We respond to inquiries from outside agencies, including the media, seeking information about the Fellowship of Alcoholics Anonymous
- 8. We support the 12 Step service of over 500 Intergroup volunteers

How does someone become an Intergroup Rep?

All AA groups/squads are eligible for membership. Groups elect an Intergroup Representative and an Alternate Representative; they usually serve a 2 year term. Each Group determines length of sobriety for their Representative however experience has shown that at least 2 years is ideal. A group must be registered with Intergroup at least five (5) days before their Representative is entitled to vote at the Intergroup Representatives Meeting.

What does an Intergroup Rep do?

Intergroup Reps and Alternate Reps attend the monthly Intergroup Representatives' Meeting. These 'Reps Meetings' are held 12 times per year on the 4th Thursday of every month unless it falls on a Holiday. Intergroup Reps are responsible for two-way communication between their Home Group and Intergroup.

Reps may have input into the agenda by calling the Intergroup Service Office or by communicating requests for agenda additions with the Board Chairperson before the Agenda is approved at the beginning of the Reps Meeting. Minutes from the previous month's Reps Meeting are available after they have been approved at the Reps Meeting. Copies of the minutes are then available at the Intergroup Office.

What are Intergroup Rep meetings like?

Representatives register with Intergroup at each Reps Meeting by providing their contact information and home group. Each Rep and home group is responsible for providing the office with current contact information to insure that AA group members have the opportunity to participate in Intergroup 12 Step Services.

Full names and contact information of individual AA members submitted to the Intergroup Service Office are kept confidential in accordance with Intergroup Bylaws and the principle of anonymity.

Notice of the Reps Meeting, including any meeting changes, is published each month in the MIRUS newsletter and on the Intergroup website.

ANNUAL BOARD ELECTIONS

Intergroup's Annual Election Meeting is on the 4th Thursday of every September. IG Reps in attendance at this meeting elect four new Board members to serve 3-year terms; this then replaces the 4 rotating off the board. Elections are conducted according to the Third Legacy procedure as outlined in, "The AA Service Manual." At least 26 Representatives (a quorum) must be present in order to conduct the election. A quorum is also needed to make any changes to the Intergroup Bylaws. Copies of the Greater Minneapolis Intergroup Bylaws are available during office hours or at the Reps meeting.

According to our Bylaws there are 12 elected Board Members. No more than 2 members can be from the same Home Group. All Board Members must have a minimum of 5 years sobriety. The 12-member elected Board has the fiduciary responsibility for the financial integrity of maintaining vital services during their term of office. The following officers are elected at the IG Board meeting the Tuesday prior to the Annual Election meeting: Chairperson, co-Chairperson, Treasurer, and Secretary. Each serves a one-year term, October 1st to September 30th, which is the Fiscal Year of Greater Minneapolis Intergroup.

The Twelve Traditions - How They Apply In Our Lives

TRADITION FOUR

"Each group should be autonomous except in matters affecting other groups or A.A. as a whole."

Basically, this tradition is telling us that each group can run their meetings however they want. The only exception is that they do nothing that would affect other groups or AA as a whole and not affiliate with an outside group. The nice thing about this tradition is that it gives each group the power to run the group that works for them.

The group can decide the time, duration and location of their meeting, how they open and close and what type of format they have.

They can decide to be a mixed group or men or women's only meeting. They can decide whether to be a closed (alcoholics only) meeting or open to all. The group can decide to be a step meeting, step and tradition meeting or they may decide to be a topic meeting and discuss a topic from the Big Book or other conference approved literature. They could read the Big Book or the 12X12, and then discuss what was read. The group could decide to be a speaker meeting or a combination speaker and discussion meeting.

The possibilities are endless. The only consideration is that the group have no affect on the welfare of another AA group.

This tradition works out very nicely for the individual member, who can quickly find a meeting that meets their own needs. I have attended many different meetings around town over the years, while working 2nd shift, raising kids and attending school and was always able to find a great meeting.

I have also attending meetings in several different states and have always been welcomed as a visitor but always felt right at home, regardless of the format of that particular group.
