July 2021 Step, Tradition, and Concept Seven

Step Seven

"Humbly asked Him to remove our shortcomings."

Humility. For me humility is the most important thing to keep in mind when doing step 7. After I do my best to do a searching and fearless moral inventory in steps 4 and 5, I am able to see where my character defects come up and how my fears impact how those defects show up in my resentments and actions. In step 6 I ask for the willingness to have those removed. Then comes step 7.

There are certain defects I still love and want to hold on to sometimes. I still love to be judgmental at times, to be selfish, self-centered. Sometimes I'd rather let my ego get big and take up the whole room. This is why I first ask for willingness to have them removed in step 6 and why I practice step 7 as humbly as I possibly can.

To truly go about it humbly, I need my higher power's help. I say the 7th step prayer several times when doing step 7: "My Creator, I am now willing that you should have all of me, good and bad. I pray that you now remove from me every single defect of character which stands in the way of my usefulness to you and my fellows. Grant me strength, as I go out from here, to do your bidding. Amen".

I know that when I'm living in my defects, I'm not being of maximum service to my higher power and to my fellows. How can I help the next still suffering alcoholic if all I'm doing is judging them? It would also be next to impossible for me to do an honest 8th step list and fully be able to make genuine amends in step 9 without first fully examining my defects of character and having them removed as much as they can be. If my ego is still huge I'll have a hard time seeing where I was in the wrong and actually admitting that. This is why I have to look at my defects first.

After working step 7 a many times over my years of sobriety I can now say it's one of my favorite steps! I've been able to remove some of my defects of character and shortcomings, and I've found that the defects I haven't been able to fully get rid of yet, are a lot less glaring.

When I was drinking I was completely unable to see outside of myself. I lashed out, I thought I was better than everyone else in the room, while at the same time feeling like the worst person on the planet and throwing myself a pity party. And I blamed others for my shortcomings. Now that I'm sober I'm able to take accountability, look people in the eye and treat them with compassion, and I no longer feel the need to lie, cheat, or steal.

Now don't get me wrong, I am by no means perfect. Nor do I work step 7 or the rest of the steps perfectly. But that's why I continue to work the steps again and again. So that I can see the holes in my program and try my best to fill them. And that's why I maintain a conscious contact with a power greater than myself. I can't do this program alone. Whenever I see my defects come up in day to day life - for example when someone cuts me off in traffic and I start to get angry, or I see myself start to act arrogantly - I pray for my higher power to relieve me of that. And oftentimes it works! I can see my defects shining through a little bit dimmer than before. And relying on God to do that for me helps me to stay humble and right sized. And that for me is the biggest thing I get from working step 7!



Twelve Concepts for World Service, written by Bill W. in 1962

Concept VII:

Short Form: The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.

The key to understanding this concept is to recognize that we are different from most other entities. There are legal aspects to how we function in the world. That is why we have a Board of Trustees that oversee our affairs and have legal rights and obligations. However, we are a spiritual society that operates under spiritual principles. We do not transact business the way other entities do. We place greater emphasis on the actions of the Conference – a body without legal power - than on our Board. It is another paradox in Alcoholics Anonymous. There are several principles at play in Concept 7. The first is balance of power. The Trustees have some power, and the Conference has some power. Legally speaking, the Trustees have the legal power to conduct our world service affairs. They are delegated the ability and discretion to keep our world services functioning under the Charter and Bylaws of the General Service Board. Their legal authority is complete. But they are not compelled to use it and historically they rely on the advice and direction of the Conference. The Conference, on the other hand, maintains practical and traditional power. The annual conference makes decisions on behalf of Alcoholics Anonymous that direct the Trustees on how to conduct our affairs. The Trustees take that advice and direction and put it into action.

The power remains balanced, and our process works because of the rest of the principles found in this Concept - trust, brotherly love, acceptance, and humility. It works because we are a spiritual society. We place tremendous value on our Traditions. The membership trusts the Conference. Everyone who serves at this level wants what is best for A.A. There might be disagreement about what is best, but we have a common goal. Our traditions guide us to extend brotherly love to those who serve us when we interact with each other. That includes when we perceive a mistake has been made. Rather than throwing people under the proverbial bus, we seek to understand and provide a different perspective or guidance as we see fit. And our tradition is to be open to differing perspectives or guidance! The group conscience provides opportunities to practice acceptance. When the group

conscience speaks, it is our spiritual practice to act on and be supportive of that group conscience. And finally, we practice humility in our affairs. Each trusted servant plays only a limited role in the ongoing success or failure of any decision made on behalf of Alcoholics Anonymous. We are in this together. If a decision later becomes clear to not be in the best interests of A.A. we can make a different decision.

I hope to see you at the upcoming Intergroup Rep's meeting where I will be making my report on this year's annual conference. It might provide more insight into Concept 7.

The Twelve Traditions - How They Apply In Our Lives TRADITION SEVEN

"Every A.A. group ought to be fully self-supporting, declining outside contributions."

It is a privilege that I was asked to write a little on the 7th tradition. "Every AA group ought to be fully self supporting declining outside contributions."

I was very new in sobriety when my sponsor began to teach me about this tradition. In our area there was an up heaval about a family member who passed and bequeathed to our district a large amount of money. Some members excitedly made plans on how this money could be spent to help the still suffering alcoholic while others held up this tradition saying we should decline the gift. The lively debate was on. Finally after much debate and a couple of months the 7th tradition won out and the gift was declined. As I sat on the sidelines and watched the drama play out my sponsor shared a little on the history of this tradition and how important it is to remain self sufficient and not accept outside donations. If interested there is much written about the 7th tradition in Twelve Steps and Twelve Tradition, Alcoholics Comes of Age, and the book Alcoholics Anonymous.

I began to start to apply this tradtion in my personal life as well. I got a job, started paying my rent (stopped borrowing from friends and family), started paying my bills on time and began to make payments on debts. What a new freedom I began to experience no longer having to avoid answering the phone and opening the mail.

The next big growth I made in practicing this tradition was in my emotional sobriety. I stopped expecting others to make me happy or blaming them for my unhappiness. I began a whole new journey in taking actions that padded my emotional bank account. I discovered yet a new freedom. Just like the financial freedom I found from creditors, I no longer am a victim. I am free to pursue joy and happiness.

I hope these few lines have piqued some questions and will encourage a little further investigation of tradition 7. AA literature and fellow AA members are rich with information.






