### Step Eight

"Made a list of all persons we had harmed, and became willing to make amends to them all."

#### **Sometimes Quickly Sometimes Slowly**

Boons Farm and Mad Dog 2020 is what I could afford at the age of 12. My sister was three years older, so through her resources of older men, there was always a supply as long as I could pay. Needless to say my teen years were filled with trouble. Suicide attempts, locked facilities, short stints in jail, fights, destructions, black outs, loosing friends from drinking, and as I got older using men to buy my liquor – to name a few. I then graduated to rum, vodka and a slow gin. I wanted the affects quick and the main one was to not feel, and the alcohol did just that. I had asked for help a few times, and there were seeds planted along the way. At the age of 18, the jig was up. I went to a 28 day program in Chanhassen. From treatment I went to a half way house in Wisconsin. Now sober, I thought my feelings for the same sex would magically disappear. Wrong. With cigarettes and coffee as my only vices, I could no longer lie, deny or hate who I was. I now love myself for who I am and have a wonderful, colorful community of sober friends from all walks of life. I was happy and grateful to be sober. I was feeling the pink cloud. I had a second chance and wanted to do everything right. I was looking forward to steps eight and nine. Working with my sponsor and the list of harms from step four, I was ready to go. My list included family members, former friends, institutions and one church in particular. There is a recommendation that the list of amends be written in three columns, today, soon, not in chance in hell. With the hope that through continued work with the steps of AA, the columns will shift. Here is where I will share my experiences, strength, hope and lessons around step eight. Without much preparation, I started to do my direct amends. I remember expecting my family to say, we are just glad you are sober Kathy Jo. Not what happened at all. In retrospect, I had made the list and was willing to make the amends to them all. What I didn't do was prepare myself on the spiritual level for zero expectations from the recipient or institutions for the amends I was making.

Today I share with my sponsees that step eight is more then about being willing. Preparing includes healing ourselves along the way, and walking into an amends with our heads held high and speaking our direct amends and ask for nothing in return.

We may have to listen to their frustrations of our alcoholic behavior which may include lying, being emotionally absent, infidelity, getting into physical altercations, and stealing. Hopefully, the work we have done with the steps, working with our sponsor, reading the 12X12, and other helpful resources will help us prepare for acceptance and centeredness. We will intuitively begin to understand that 1% is the direct amends and 99% is the living amends. It has been my experience that most people will sense the difference in us as we are making our amends. They will wish us well on our sobriety journey, and others may tell us to get away and stay away. The key is not to let their reaction in any way affect our spiritual foundations. The reactions that were the most difficult for me to hear are the ones that helped me stay sober today.

These last five years have been the most difficult for me in my sobriety. Since 2021, I have been attending at least one AA zoom meeting a day. This has been extremely powerful with the continuation of my sobriety. A friend asked me to write this article about the eight step. I immediately thought of the last item on my list of amends. The next day, I drove back to River Falls with a good friend, blank check and medallion in my pocket. At the elementary school, I was ready. I opened the front door to a friendly woman who greeted me and asked if she could help. With unexpected tears coming down my face, I told her I was there to make a financial amends for some windows I had broken in the mid 70's. To my surprise, she said cheerfully, come on in. Now I am in the principals' office, for quite a different reason then in my youth. I explained that I was in recovery for over 41 years. As he graciously accepted the check, a powerful wave came over me, and I asked him to consider purchasing AA literature for kids like me, struggling with drinking. As I left, I walked to my car with my head held high.

### Twelve Concepts for World Service, written by Bill W. in 1962


#### Concept VIII:

Short Form: . The Trustees of the General Service Board act in two primary capacities: (a) With respect to the larger matters of over-all policy and finance, they are the principal planners and administrators. They and their primary committees directly manage these affairs. (b) But with respect to our separately incorporated and constantly active services, the relation of the Trustees is mainly that of full stock ownership and of custodial oversight which they exercise through their ability to elect all directors of these entities. The General Service Board is responsible for managing the affairs for Alcoholics Anonymous. But it would be difficult for them to manage everything – large matters and small ones – well. We don't want them to be distracted from the big picture by the minutia of the day-to-day operations. Imagine if a CEO of a business had to be involved in the ordering of office supplies! It would not be a very efficient or effective way to run a business. Instead, the General Service Board is intimately involved in matters related to our policies and our finances. Members of the General Service Board serve on the AAWS and Grapevine Boards. They provide oversight that is custodial through the directors of our various entities – AAWS and Grapevine - who manage things on their behalf. The General Manager of GSO reports to the AAWS Board and the Grapevine Editor reports to the Grapevine Board. That is how our active services are managed. Here is an analogy in relation to Minneapolis Intergroup. The Board of Minneapolis Intergroup has responsibility for overall management of Minneapolis Intergroup. When I served on the Board several years ago, our manager departed for an opportunity to work at the General Service Office. The Board was responsible for hiring a replacement manager. Members of the board served on the hiring committee. We conducted interviews and ultimately hired Gail to be our new manager. The Board was responsible for hiring that position, but they trust the individual to manage the day-to-day affairs of the office. Gail hires and manages other employees and oversees the overall functioning of the office. The board is kept abreast of everything but they don't micromanage the manager or the management of the office. The end result is that we have checks and balances. Our leaders lead and our managers manage. If you want to learn more about the details surrounding the structure of our service entities, please pick up a copy of the A.A. Service Manual. A newly updated version will be available soon and I'm sure Gail will have them at the office. You may also order them from aa.org. ## The Twelve Traditions - How They Apply In Our Lives TRADITION Eight

#### Reprinted from the July 1948 Grapevine

"Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers."

Throughout the world AAs are twelfth-stepping with thousands of new prospects a month. Between one and two thousand of these stick on our first presentation; past experience shows that most of the remainder will come back to us later on. Almost entirely unorganized, and completely nonprofessional, this mighty spiritual current is now flowing from alcoholics who are well to those who are sick. One alcoholic talking to another; that's all.

Could this vast and vital face-to-face effort ever be professionalized or even organized? Most emphatically, it could not. The few efforts to professionalize straight Twelfth Step work have always failed quickly. Today, no AA will tolerate the idea of paid "AA therapists" or "organizers." Nor does any AA like to be told just how he must handle that new prospect of his. No, this great life-giving stream can never be dammed up by paid dogooders or professionals. Alcoholics Anonymous is never going to cut its own lifelines. To a man, we are sure of that.

But what about those who serve us full time in other capacities-are cooks, caretakers, and paid intergroup secretaries "AA professionals"?

Because our thinking about these people is still unclear, we often feel and act as though they were such. The impression of professionalism subtly attaches to them, so we frequently hear they are "making money out of AA" or that they are "professionalizing" AA. Seemingly, if they do take our AA dollars they don't quite belong with us AAs anymore. We sometimes go further; we underpay them on the theory they ought to be glad to "cook" for AA cheap.

Now isn't this carrying our fears of professionalism rather far? If these fears ever got too strong, none but a saint or an incompetent could work for Alcoholics Anonymous. Our supply of saints being quite small, we would certainly wind up with less competent workers than we need.

We are beginning to see that our few paid workers are performing only those service tasks that our volunteers cannot consistently handle. Primarily those folks are not doing Twelfth Step work. They are just making more and better Twelfth Step work possible. Secretaries at their desks are valuable points of contact, information, and public relations. That is what they are paid for, and nothing else. They help carry the good news of AA to the outside world and bring our prospects face to face with us.

That's not "AA therapy"; it's just a lot of very necessary but often thankless work.

So, where needed, let's revise our attitude toward those who labor at our special services. Let us treat them as AA associates, and not as hired help; let's recompense them fairly and, above all, let's absolve them from the label of professionalism.

Let us also distinguish clearly between "organizing the AA movement" and setting up, in a reasonably businesslike manner, its few essential services of contact and propagation. Once we do that, all will be well. The million or so fellow alcoholics who are still sick will then continue to get the break we sixty thousand AAs have already had.

Let's give our "service desks" the hand they so well deserve.






