Step Ten

Inventory? Didn't I take care of that back at Step 4?
Maintenance? Perseverance?

No thank you. I really wanted to stay sober, but I felt as though maybe I had been humbled enough. My sponsor, however, had other ideas, and thank God for that!

When I first started doing a nightly inventory, I did it as it was laid out in the big book. While I did it most nights, I wasn't very consistent, and eventually stopped altogether.

A few years later into sobriety, a friend and I challenged each other to do it nightly, and she even had a worksheet! Easy peasy!

I had a different sponsor by then and had told her my plan, complete with a copy of the worksheet. She was unimpressed.

She pointed out that our template highlighted only the negative, and didn't allow for anything positive from the day.

That method clearly didn't last.

These days, while I don't "formally" write out a 10th step, I do review my day every night...well, sometimes I have to continue in the morning because I have a tendency to fall asleep!

I may not write it out any longer, but I have learned to do a 'gut check' throughout the day.

I haven't perfected the 'PAUSE' that we learn in this program, but I can identify pretty quickly when I'm wrong, and am able to promptly admit it. Sometimes though, I can take it to the extreme, (I am, after all, an alcoholic), and own others' mistakes as my own if I feel that I somehow had a part in it.

It's progress, not perfection, and that can be difficult for an alcoholic like me, who isn't satisfied with the slow moving wheels of progress.

We need always remember that alcohol is a subtle foe. It is patient. All we have is a daily reprieve based on our spiritual condition.

Notes from your Service Office:

The General Service Theme for 2021 is:

“Practicing A.A.’s Spiritual Principles in a Changing World.”

A new fiscal year begins for Minneapolis Intergruop. We thank the four board members that just rotated off the Board. Believe me when I say they served selflessly to be sure Intergruop’s vital service remained strong and true. From the beginning of the pandemic, we never closed our doors. There were situations at times the Board played a key role in preventing that from happening. They will be missed tremendously.

And we are grateful for their service. Thank you Deb W., Patti P., Dwight C., and Mark M.

We welcome our newly elected Board members from the September 23rd elections. Their willingness to serve is all they need to be qualified. The only requirement stated is a minimum of five years of continuous sobriety.

This month we will be updating the 12th Step List. We currently have 351 members on the list in 72 different cities. In 23 of these cities we only have 1 person listed. Which means we do not have both male and female in that area available.

Everyone on the list will be called to verify that you are still willing and able to be on the list. If you cannot be reached, we will leave

a message for you to notify us with a phone call by a certain date that you want to be of service. If you do not respond we will understand that to mean you are no longer available and your name will be removed.

In case you may be new and have never heard about this service, the 12th Step list is a vital service of Minneapolis Intergruop. If you volunteer to be on the list, your name will be listed under the city you live in. When a person calls our hotline number and says they need help with their drinking problem, they are asked if they want to have a sober member in Alcoholics Anonymous call them back in 15-20 minutes to talk with. If so, we look for someone that lives in their area. That person may be you. What we promise is a phone call. That’s all. But many have connected in meetings and became life long fellow members. We can never have too many members on the 12th Step list. If you want to serve on the 12th Step list. You can fill out the “Contribute Your Time” form found on the aaminneapolis.org website under the tab

“About Intergruop” and then click on “Service Opportunities. Forms are also available at the office.

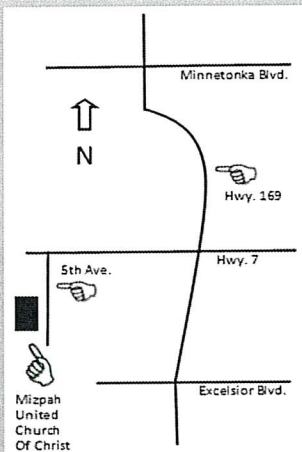

Twelve Concepts for World Service, written by Bill W. in 1962

Concept X: *Every service responsibility should be matched by an equal service authority – the scope of such authority to be always well defined whether by tradition, by resolution, by specific job description or by appropriate charter and bylaws.*

There are two parts of this Concept to understand when you agree to serve in Alcoholics Anonymous. The first is that doing so carries with it responsibilities. Agreeing to take a service role, no matter what level of the AA organization, carries with it certain duties that are entrusted to each person serving in that role. The other concept is authority. Each role and level of service is delegated a level of authority to get the job done. Our fellowship functions well when we understand the how these concepts work together and what to do when, if ever, they are not being respected. Every level of service carries with it a responsibility. In my role as delegate, I am responsible for being a conduit of communication between the General Service Conference and the AA members in Southern Minnesota. Information is funneled through me to the Area. Similarly, Area 36 communicates through me to the General Service Conference. The primary example is the annual conference. I am the representative from Area 36 currently participating at the conference. As such, I am responsible for reading and understanding the agenda items and background information that is provided to the fellowship in February. I am also responsible for making sure said information is disseminated to the AA members in Southern Minnesota. I am also responsible for soliciting and listening to feedback from the membership in Area 36 to help me be informed about how AA members in our Area think and feel about items that will be discussed at the conference. There are a number of other responsibilities for the role of delegate. There are also responsibilities for group chairs, general services representatives, district and area officers and committee chairs, trustees, GSO staff, etc. We are all responsible for the duties connected with our roles in AA. No one could perform their duties, however, if they didn't have the authority. In the case of delegate, Area 36 votes every two years to elect a delegate. That is where I got my authority. The eligible voters in Southern Minnesota voted in October of 2020 to elect me as the Panel 71 Delegate. That is where I got my authority. I am entrusted to be the representative from Area 36 who will serve the fellowship at-large to the best of my ability for two years. I am authorized to vote at the conference and to represent Southern Minnesota in every way that is needed. In the case of a General Service Representative, the group elects the GSR to represent them and they give him or her the authority to do so. At the 71st General Service Conference, I voted in a slate of Trustees and in doing so I was one of a majority of people that granted them the authority to serve us as Trustee. It is our practice to grant our trusted servants the authority they need to do their job. Bill gave us two warnings in his essay on Concept X. He said that only in emergency circumstances should delegated authority be interfered with. He said as long as it is functioning well, it should be allowed to function. He

went on to say that if delegated authority was being misused or rendered ineffective, it might be time to contemplate a reorganization. So far, that has not happened. I have learned so much about myself and how to be a responsible citizen of the world here. I also learned about humility and not crossing the line of authority that has been granted to exercise responsibilities that aren't mine to exercise. AA service continues to be a great teacher for my life.

The Twelve Traditions - How They Apply In Our Lives

TRADITION TEN: Alcoholics Anonymous has no opinion on outside issues, hence the A.A. name ought never be drawn into public controversy.

To most of us, Alcoholics Anonymous has become as solid as the Rock of Gibraltar. We like to believe that it will soon be as well-known and just as enduring as that historic landmark. We enjoy this pleasant conviction because nothing has yet occurred to disturb it; we reason that we must hang together or die. Hence we take for granted our continued unity as a movement. But should we? Though God has bestowed upon us great favors, and though we are bound by stronger ties of love and necessity than most societies, is it prudent to suppose that automatically these great gifts and attributes shall be ours forever? If we are worthy, we shall probably continue to enjoy them. So the real question is, how shall we always be worthy of our present blessings?

Seen from this point of view, our AA Traditions are those attitudes and practices by which we may deserve, as a movement, a long life and a useful one. To this end, none could be more vital than our Tenth Tradition, for it deals with the subject of controversy—serious controversy.

On the other side of the world, millions have died even recently in religious dissension. Other millions have died in political controversy. The end is not yet. Nearly everybody in the world has turned reformer. Each group, society and nation is saying to the other, "You must do as we say, or else." Political controversy and reform by compulsion have reached an all-time high. And eternal, seemingly, are the flames of religious dissension.

Being like other men and women, how can we expect to remain forever immune from these perils? Probably we shall not. At length, we must meet them all. We cannot flee from them, nor ought we try. If these challenges do come, we shall, I am sure, go out to meet them gladly and unafraid. That will be the acid test of our worth.

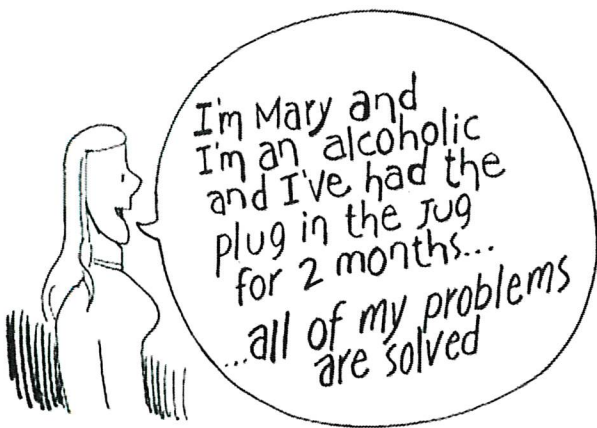
Our best defense? This surely lies in the formation of a Tradition respecting serious controversy so powerful that neither the weakness of persons nor the strain and strife of our troubled times can harm Alcoholics Anonymous. We know that AA must continue to live, or else many of us and many of our fellow alcoholics throughout the world will surely resume the hopeless journey to oblivion. That must never be. As though by some deep and compelling instinct, we have thus far avoided serious controversies. Save minor and healthy growing pains, we are at peace among ourselves. And because we have thus far adhered to our sole aim, the whole world regards us favorably.

May God grant us the wisdom and fortitude ever to sustain an unbreakable unity.

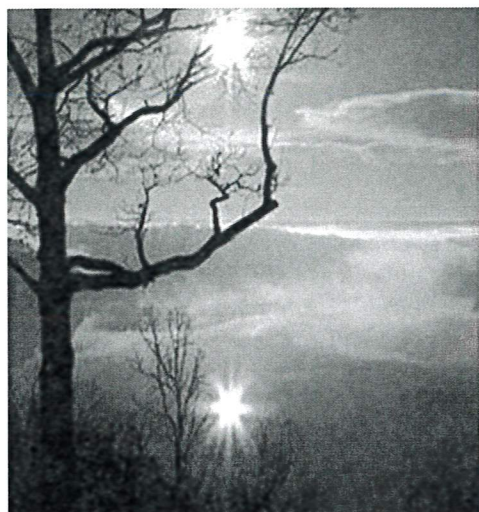

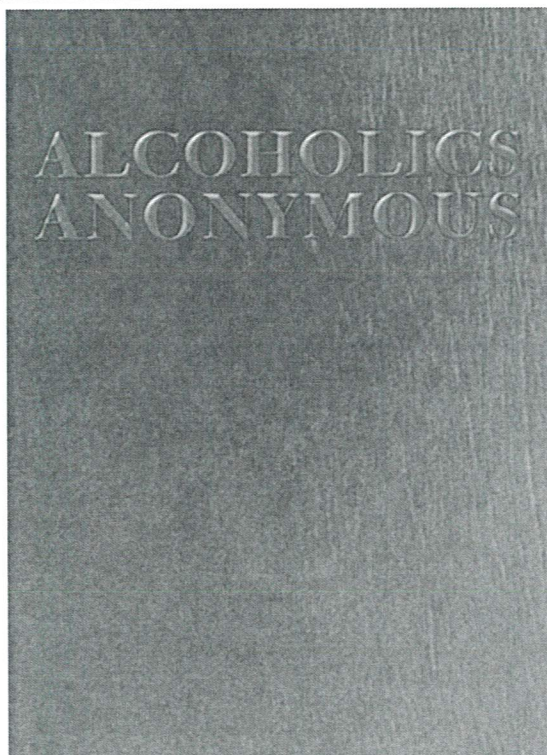
