September 2022 Step, Tradition, and Concept Nine

"Made direct amends to such people wherever possible, except when to do so would injure them or others."

After I started going to A.A. and working the steps, it took a couple of years before I would start my 9th Step. I had been convinced that "...there is a long period of reconstruction ahead," as it says in the Big Book. But I would get stuck on the next sentence, "We must take the lead. I was full of fear and wasn't getting past that fear.

My drinking life had been filled with running away. I spent all my time trying to latch onto someone who I just knew would take care of me and everything else. This never worked out very well so I would run away and find someone else. But in A.A. I was learning how to take care of myself and what I was responsible for. I finally started to grow into an adult. So I had slowly worked the steps with a sponsor and had completed an 8th Step list. Then I stalled.

It wasn't until after I was arrested for shoplifting at the age of 37 that I was compelled to start the 9th Step in earnest. Prior to my arrest, I hadn't felt the need to change this behavior because I wasn't drinking. When I got home from the police station I called my sponsor and told her what had happened. She said "Go to your bedroom, get on your knees and thank god that this happened." I thought she must not have heard what I said!

But I was sober enough to DO what she said. And while it took about three years to actually feel gratitude for this, it did make me start actually doing the 9th Step and that was the first thing I felt grateful for.

My first amend was about the shoplifting, because it was in front of my mind. And while II had to do a certain number of hours of community service, that wasn't an amend, that was a consequence. The amend was demonstrating that I could admit my fault by making things right and changing my behavior. I had no idea how to pay back money because I had been shoplifting for years and from any store I went into. My sponsor and I talked this out and I took her suggestion to pick three organizations and contribute regularly to them for a number of years. I was scared to do this because I was in the middle of a difficult divorce and didn't have a job or a place to live yet. But I eventually picked three organizations that help children of incarcerated people and contributed to them monthly for five years. And to this day I've never stolen anything again and I really am grateful that I got caught.

That amend was probably the easiest one I did. It made perfect sense and I changed my behavior. But my other amends involved talking to people face-to-face and admitting my faults, expressing remorse, and changing my behavior regarding this person; that sounded impossible. Going through the list with my sponsor was essential. I am sure I would have lied and pretended to act if I hadn't been able to talk things out with her. I moved to a different city in the middle of Step 9 so I had another sponsor to talk through the rest of the list. These two women gave so much wisdom and experience and time to me, I am forever indebted to them.

When we started, I would pick a name that I sort of thought, maybe, sometime I would be able to make amends to. We would talk through what exactly I did that needed making right. This was useful because I learned that I didn't have to take responsibility for everything that happens, just my part in it. I practiced out loud what I would say and sometimes I had to write it down and read it out loud to the person. I was so scared to do this that all thoughts would just leave my head, so I needed to read it.

Doing this got easier the more I practiced. It was easier to see what my part was, what needed saying, what behavior needed changing.

I became aware on a deep level how I had lived my life as if I were performing a part in a play. The thought of anyone, from my parents to the cashier at the grocery store, seeing who I really was petrified me. But the action of being honest, especially with someone I loved, like my family, and letting them see me being honest was transforming. I simultaneously felt like an honest person on the inside, and I became less scared of what other people thought of me.

The gifts of Step 9 have been awesome and life-changing. Because I had good sponsorship, I was painstaking about this step. I felt like a human being that was a part of the world and could navigate my responsibilities and feel relatively grown-up! Because I have an alcoholic brain, I realize there are other actions I need to do to continue to keep these gifts. I have not always done them. But I know what to do any time I am ready to have these gifts again. I stay close to the people and the program of A.A. and they show me how.

Twelve Concepts for World Service, written by Bill W. in 1962

Concept IX "Good service leaders, together with sound and appropriate methods of choosing them, are at all levels indispensable for our future functioning and safety. The primary world service leadership once exercised by the founders of A.A. must necessarily be assumed by the Trustees of the General Service Board of Alcoholics Anonymous."

Good leadership in A.A. is vital to our ongoing success. In a 1959 essay on leadership in the A.A. Grapevine, Bill W. wrote "no society can function well without able leadership in all its levels, and A.A. can be no exception." What makes a good leader in A.A.? There are four qualities referred to in the essay that I want to highlight.

The first is dedication. In A.A. we learn to do what we say we are going to do. We are taught to give back what is freely given to us. That is essentially what dedication is! Staying sober one-day-at-a-time and being of service to others requires dedication. We take daily actions that make it possible to not drink anymore. We help others because our life and theirs depends on it. We dedicate ourselves to carrying the message to others because we can help where no one else can. This is how an A.A. leader begins to be formed.

Next is stability. One of the synonyms for stability is steadiness. Before A.A., I was tremendously unstable. Thanks to the steps, traditions, service, and sponsorship, I have been described as a "steady as she goes" member of Alcoholics Anonymous. Service in A.A. brings stability to our lives. As I became accountable to my home group, to sponsees, to a sponsor, and later to the district and area, my life stabilized in other areas too. I learned how to show up for work and pay my bills on time. If I focus on being of service in A.A. the other areas of my life are more stable and when something tries to rock the boat, service to others helps calm the waters.

The third quality is vision. Another word for vision is dream. It is good to have dreams for A.A. We dream that our meetings will stick around for the next generation. We have ideas on how to make our meeting better or how to be a better sponsor. We also might have suggestions on how to better carry the message to the still-suffering alcoholic. All of this is vision for the future well-being of us and our Fellowship.

The last quality referred to is "special skills." Each A.A. leader brings something to the table. It might be enthusiasm or strong public-speaking skills. It could be a background in typing or publishing that lends itself well to the district or area newsletter. It could be keen math skills that lend themselves to a treasurer position. There are too many skills that are helpful in A.A. to list them all. Bill once remarked "it is said that leaders are born not made, but in A.A. paradoxically, we do make them." We need a variety of skills to keep our Fellowship strong.

Tradition Two says our leaders are but trusted servants. We make leaders by trusting our members to use their unique qualities and our principles to serve us well. I hope you will take the opportunities you are presented to use your skills and help lead A.A. into the next phase of our development.

- Your Home Group should be located within the confines of the Metro Minneapolis Suburban Area.






