March 2023 Step, Tradition, and Concept Three

"Made a decision to turn our will and our lives over to the care of God as we understood Him ."

As I mature and evolve in the program of AA, the steps continue to take on different perspectives. I did not and do not work the steps as one and done, but more like with the beginning of each step, I do a quick review of the previous steps. The minute I forget about any of the previous steps is when I start taking half measures. For me step three started in my probation officer's office who said I had to go to treatment. As much as I was hesitant, I remembered what I prayed for after being pulled over for my 2nd DWI; I wanted help. I did not know what to do; I listened and went. While in treatment, I was hesitant to step in the rooms of AA. My counselor said "go to AA or don't come back", so I went. Stepping into my first meeting is when my life started changing drastically. After hitting my bottom, truly admitting I was an alcoholic, and having no idea what I was doing, I made a decision to start taking direction. Direction other people took to improve their lives. And for that I am grateful.

Recovery is a personal spiritual journey. But even the most spiritual people need guidance. Letting go and letting God is one of the scariest things I did. While I still made many good decisions, there were many bad. I had to sort those out and sort out my life and see where my characteristics went awry. It was suggested that I do a fearless inventory. Doing this I started seeing the negative patterns of my behavior. I saw where I tried controlling or inserting my will on others. Without doing this, I would have never seen how my behaviors affected others, and how I was blocking the sunlight of the Spirit to grow.

Of course, I could have sat on this Step, but then I would once again be taking back my will, exact opposite of Step 3. I shared my inventory with a sponsor, and a spiritual advisor. Now it was out in the open, and I could be called out when I tried doing it my way. My way never got me far. I could now get guidance when negative behaviors reared their heads. I just had to keep an open mind.

Turning my will over also did not mean that all answers would be placed in my lap. I still had to take action everyday. I saw how all my defects were running my life, and knew I no longer wanted to live with them. I could pray for change. Praying for them to be taken away did not just remove them. Sobering up also did not make me an automatic Saint. I would have to face many circumstances that would bring to the forefront those defects. I had to be open suggestions. Suggestions on how to change. I had to work and be aware when they cropped up. Of course,

when I prayed for patience, I got stuck in the slowest lane in a store. God did not just give me patience; He allowed me to learn how to gain patience. Just getting it was my will, having patience to gain patience is God's will.


One thing I realized was when something cropped up, that feeling in the gut that did not sit well, was because I said, did, or even did not do something. I had to see where I wanted something to work out in my favor or was too scared to take action. My will use to be to just sit in it and brush it under the rug, but we all know where that gets us. I prayed for change and I prayed for help. I was given the tools to amend those defects and now I had to put them once again into action.

After a few one day at a time, I incorporate this step in my life every day. I especially work this step in-tandem with Step 11. As I get nudges from sponsors, friends, family, and my understanding of God, I must trust what is out there is for the better, and I have no idea how the universe works.

Step Three for me is not passively having something run your life, but the courage to gain humility to change. I made a decision, but I also gained courage to follow through.

Nelson Mandela once said: "I learned that courage was not the absence of fear, but the triumph over it." The Steps work if you work them!

On March 25 we will be gathered together for Gratitude Night. This will be an extra special evening, as we will celebrating the 40<sup>th</sup> anniversary of this remarkable event.

This is an opportunity for our A.A to come together to express our sincere feelings of thanks to those who have given so much of their time over the past year to help the still suffering alcoholic.

Although Minneapolis Intergroup is a small organization, employing only four employees, with the assistance of its many volunteers, it is able to provide help to alcoholics throughout our metro area. So, at Gratitude Night we say thank you to all of these volunteers.

Through these volunteers, Minneapolis Intergroup is able to answer calls for help on a twenty-four-hour basis, seven days a week, 365 days a year. These phones are answered at the office during normal business hours, by A.A. groups in our phone room in the evenings and on week ends and at night and early morning

by our Night Owls and Early Birds. This phone answering service is impressive, but it is only one aspect of the services that volunteers provide.

On a regular basis we have sixty to seventy Intergroup Representatives attending our monthly Representatives meeting. We have devoted A.A. volunteers coordinating Temporary Contact programs for Corrections and Treatment. We have additional volunteers making the rounds giving AAI talks. And for events like Gratitude Night we have a whole army of volunteers working to make the event possible. To top it all off, we have a Board of Directors that are dedicated to ensuring that this entire program remains viable.



# Twelve Concepts for World Service, written by Bill W. in 1962

As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."

I thought it might be good to return to the Conference Charter to open this discussion on Concept III. The current Conference Charter says:

3. Conference Relation to A.A.: The Conference will act for A.A. in the perpetuation and guidance of its world services, and it will also be the vehicle by which the A.A. movement can express its view upon all matters of vital A.A. policy and all hazardous deviations from A.A. Tradition. Delegates should be free to vote as their conscience dictates; they should also be free to decide what questions should be taken to the group level, whether for information, discussion, or their own direct instruction.

I also like to return to The Concepts Checklist, which poses these two questions for Concept III:

- Do we understand what is meant by the "Right of Decision"? Do we grant it at all levels of service or do we "instruct"?
- Do we trust our trusted servants G.S.R., D.C.M., area delegate, the Conference itself?

Concept III invites us essentially to trust our trusted servants, at all levels of service. The AA groups hold the authority and final responsibility for our world services. But we can't all be involved in every decision, and execution of every action approved, by the conference, that just wouldn't be practical. We must trust others; our GSRs, DCMs, and our Delegate to serve us in the best, most informed way possible. GSRs and DCMs bring us information to discuss, and they carry our conscience from the home group and the district. Our Delegate is elected by those trusted servants to do the same, bring information to the area and to bring the area conscience to the conference. In addition to this work at the area level our Then we trust our Delegate to serve A.A. as a whole at the conference. All along the way the "right of decision" is key to serving A.A. in the best, most thoughtful way.

The Conference is a decision-making body. Delegates, along with Trustees, and certain GSO Staff members will consider items for action or no action. The participants come from all over the U.S. and Canada, and bring different viewpoints to the

discussion. We've seen different viewpoints in play at the home group, during business meetings. As at any other business meeting, at the conference the perspective of all is carefully offered and listened to, so the conference body can come to the best decision for A.A. as a whole. Substantial unanimity can only be reached through the use of "right of decision" which allows trusted servants to vote based on all they have heard collectively, from their areas, and from the conference discussion. Along with the right of decision, Delegates have the responsibility to return to the Fellowship with a full report, letting people know what happened, how we voted, and most importantly why we voted the way we did.

The "right of decision" is integral to serving A.A. by remembering Tradition Two, which reminds us that there "is but one ultimate authority – a loving God as he may express Himself in our group conscience". The "right of decision" allows each trusted servant to vote using the full information they have at the time, for the best outcome for A.A. and trusting in the Higher Power to guide us along the way.

We will have lively discussions in the next few months regarding the conference agenda items, I'm looking forward to them! I will do my best to provide you with as much background information as I can, on as many agenda items we think we can reasonably discuss. In that way Area 36 will be informed, and will inform me, as your Delegate to the conference. It is an honor to serve you, and a responsibility not taken lightly. I am grateful to be a trusted servant, trusted with the right of decision, for the good of A.A. as a whole.

# The Twelve Traditions - How They Apply In Our Lives

Tradition Three— The only requirement for A.A. membership is a desire to stop drinking.

FEBRUARY 1948 Editorial: BY: BILL W.

"Our membership ought to include all who suffer alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation."

This is a sweeping statement indeed; it takes in a lot of territory. Some people might think it too idealistic to be practical. It tells every alcoholic in the world that he may become, and remain, a member of Alcoholics Anonymous so long as he says so. In short, Alcoholics Anonymous has no membership rule.

Why is this so? Our answer is simple and practical. Even in self protection, we do not wish to erect the slightest barrier between ourselves and the brother alcoholic who still suffers. We know that society has been demanding that he conform to its laws and conventions. But the essence of his alcoholic malady is the fact that he has been unable or unwilling to conform either to the laws of man or God. If he is anything, the sick alcoholic is a rebellious nonconformist. How well we understand that; every member of Alcoholics Anonymous was once a rebel himself. Hence we cannot offer to meet him at any half-way mark. We must enter the dark cave where he is and show him that we understand. We realize that he is altogether too weak and confused to jump hurdles. If we raise obstacles, he might stay away and perish. He might be denied his priceless opportunity. So when he asks, "Are there any conditions?" we joyfully reply, "No, not a one." When skeptically he comes back saying, "But certainly there must be things that I have to do and believe," we quickly answer, "In Alcoholics Anonymous there are no musts." Cynically, perhaps, he then inquires, "What is this all going to cost me?" We are able to laugh and say, "Nothing at all, there are no fees and dues." Thus, in a brief hour, is our friend disarmed of his suspicion and rebellion. His eyes begin to open on a new world of friendship and understanding. Bankrupt idealist that he has been, his ideal is no longer a dream. After years of lonely search it now stands revealed. The reality of Alcoholics Anonymous bursts upon him. For Alcoholics Anonymous is saying, "We have something priceless to give, if only you will receive." That is all. But to our new friend, it is everything.

Without more ado, he becomes one of us.

Our membership tradition does contain, however, one vitally important qualification. That qualification relates to the use of our name, Alcoholics Anonymous. We believe that any two or three alcoholics gathered together for sobriety may call themselves an A.A. group provided that, as a group, they have no other affiliation. Here our purpose is clear and unequivocal. For obvious reasons we wish the name Alcoholics Anonymous to be used only in connection with straight A.A. activities. One can think of no A.A. member who would like, for example, to see the formation of "dry" A.A. groups, "wet" A.A. groups, Republican A.A. groups, Communist A.A. groups. Few, if any, would wish our groups to be designated by religious denominations. We cannot lend the A.A. name, even indirectly to other activities, however worthy. If we do so we shall become hopelessly compromised and divided. We think that A.A. should offer its experience to the whole world for whatever use can be made of it. But not its name. Nothing could be more certain. Let us of A.A. therefore resolve that we shall always be inclusive, and never exclusive, offering all we have to all men save our title. May all barriers be thus leveled, may our unity thus be preserved. And may God grant us a long life -- and a useful one!




